As many of you as were baptized into Christ have clothed yourselves with Christ. There is no longer Jew or Greek, there is no longer slave or free, there is no longer males and female; for all of you are one in Christ Jesus. Lead a life worthy of the calling to which you have been called, making every effort to maintain the unity of the Spirit in the bond of peace. There is one body and one Spirit, just as we were called to the one hope of our calling, one Lord, one faith, one baptism, one God and Father of all, who is above all and through all and in all.

Report of the General Presbyter of the Presbytery of Sheppards and Lapsley Sue Westfall January 2024

Greetings to you in this new year! For this meeting of the presbytery we are meeting at the historic Northern Heights Presbyterian Church in Selma. There is no longer a worshipping congregation in this building but the presbytery has retained the property and is seeking partners to ensure a Presbyterian presence in this historic city facing so many challenges. The Anti-Racism Committee has taken on the role of the host church and we thank them for their hard work on this. The presbytery will conduct its business in the morning, share lunch, and then there is the opportunity to take part in an interactive simulation experience led by Afriye We-kandosis at By the River. I can assure you it is a powerful experience and I hope you will participate. And thank you in advance for your flexibility and spirit of learning and adventure in what will be a unique presbytery meeting.

Meanwhile, here is a glimpse of what I am seeing around the presbytery:

- We continue to lean into our commitment to be a Matthew 25 presbytery. The presbytery's Anti-Racism Committee provides opportunities to come to terms with our own racism and with our partner, Faith in Action Alabama, we take steps to dismantle structural racism in our state. The Presbytery's Main Event Committee offers opportunities to increase the vitality of our congregations with workshops on dynamic preaching, building deeper community, and developing innovative relationships with partners in mission. Congregations throughout the presbytery continue to chip away at eradicating systemic poverty which is so prevalent here in Alabama and around the world with housing programs, food programs, and legislative action.
- This is the season of the year during which much of our presbytery leadership "passes the mantle" to new leadership. Welcome with me Deborah Thomas (RE, First Auburn) as our new Moderator (her father was the moderator of this presbytery in 1991), and Vice Moderator, Jonathan Yarboro (TE, First Presbyterian, Wetumpka). Thank you to Susan Haskell (RE, IPC) who has faithfully concluded her three-year cycle of serving as Vice-Moderator, Moderator of Presbytery, and Moderator of Council. Thank you for your leadership, Susan! Thank you to all members of the presbytery's committees and commissions who are rotating off and thank you to all who are coming on! The new presbytery directory will be available late February so check it out to find out who these new leaders are! We are blessed with remarkable leaders in this presbytery and our witness and work are more faithful and effective because of it.
- We had the joy this past year of welcoming new clergy colleagues Rachel Winter, installed as pastor at Oakmont Chapel (Birmingham), In Chan Bae,

- installed as pastor of Korean Presbyterian of Birmingham, and Caroline Kelly at Grace Presbyterian who we will examine for membership in the presbytery today.
- At this meeting we will also remember and honor all the saints of our presbytery who entered the church triumphant this past year. We build on their legacy of faith and dedication with profound thanksgiving.
- Just as individuals have a life-cycle so do congregations and we are facing the closure of some of our congregations. Administrative Commissions to close or merge churches are currently in place for Five Mile, Fairfield Highlands, and 2<sup>nd</sup> Presbyterian. The bulk of the sale will go to new church development and revitalization. In such a distribution these closing churches plant seeds of new life to the church at large.

At the same time, our world, our nation, our state, and our communities are dying and dealing death. Presbytery of Sheppards and Lapsley Guidelines for Distribution of Funds Received from the Dissolution/Dismissal of Congregations December 13, 2023

The property of the Presbyterian Church (USA), of its councils and entities, and of its congregations, is a tool for the accomplishment of the mission of Jesus Christ in the world. (G-40201)

All property held by or for a congregation, a presbytery, a synod, the General Assembly, or the Presbyterian Church (USA), whether legal title is lodged in a corporation, a trustee or trustees, or an unincorporated association, and whether the property is used in programs of a congregation or of a higher council is retained for the production of income, is held in trust nevertheless for the use and benefit of the Presbyterian Church (USA). (G-4.0203)

Seeking, as a presbytery, to be faithful to the mission of Jesus Christ in the world, the Presbytery of Sheppards and Lapsley adopts the following policy that shall ordinarily apply to the dissolution or dismissal of a congregation noting that this policy does not automatically apply to congregations which were exempted from the Trust clause(G-4.0203) following the reunion of the Presbyterian Church in the United States and the United Presbyterian Church in the United States of America to form the Presbyterian Church (USA). The presbytery office keeps a record of all the congregations that duly took the "Southern Option." (G-4.0208)

This policy is in effect for the net proceeds of the property. Net proceeds are any monies remaining from the sale of any real estate owned by a church which has been closed after (a) all financial obligations of the church have been paid; (b) Presbytery has been reimbursed for any funds disbursed on behalf of the congregation during or after the dissolution process. In the event that the property is leased with or without an option to purchase, proceeds will become available when the rental is received and/or the full purchase amount is received.

#### Distribution will be as follows:

- 10% a first fruit offering for use by the congregation/session distributed to
  Presbyterian causes and institutions that have been meaningful to the life of the
  congregation and/or local ecumenical and benevolent causes that have been
  meaningful to the life of the congregation.
- 10% to the operating fund. Intended to help support the total ongoing presbytery ministry funded by the annual Operating Budget.
- 70% to Church Development and redevelopment/revitalization funds. Intended to promote new church development opportunities, new worshipping communities, and the redevelopment of existing congregations and ministries that are purposefully pursing plans designed to encourage and enhance vitality and growth of congregations.

- 10% to Reparative Justice. Starting with our specific history of complicity in actions that have favored certain communities over others, establish a fund that would use the money for reparative action efforts:
  - 1. Reparative action within the Presbytery community
  - 2. Reparative action beyond the Presbytery community
  - 3. Matching grants for congregations doing reparative action

From the Advisory Committee on Social Witness Policy (2020) "Encourage presbyteries to account for histories of race-based injustice when making choices about the disposition of properties when they are being sold or reallocated, attending to the wisdom of reparative justice and questions about, e.g., the origins of those properties, the means by which they were maintained, their potential use, the presence of historically marginalized communities in the area, and the impact of those properties on those communities."

Proposed Overture to the 226th General Assembly (2024) passed w.o. dissent on 6-17-2023

## An Overture to the 226th General Assembly (PCUSA) from the Presbytery of Santa Fe

The Presbytery of Santa Fe respectfully overtures the 226th General Assembly (2024) to approve and send to the presbyteries for ratification the following new paragraph to the Form of Government, following G-1.0103:

G-1.0104 Other Forms of Corporate Witness (Small Worshipping Communities, etc.)

In circumstances where the formation of a traditional ecclesiastically and legally organized congregation is not desired or deemed appropriate, but a worshipping community nonetheless wishes to exist and function in relationship to The Presbyterian Church (U.S.A.), presbyteries and congregations may work together with such a group to provide supervision and support. Such recognized groups shall be under the mutually agreed upon oversight of a minister of the Word and Sacrament approved by the presbytery, shall include at least one ruling elder in their chosen leadership, and shall function under the financial, legal, and disciplinary sponsorship of an ecclesial council (either a session or a presbytery). The sponsoring council shall, in consultation with the worshipping community, authorize any celebrations of the sacraments within the group in accordance with the Directory for Worship. Membership records for group participants desiring to be formally enrolled as baptized, active, or affiliate members in the PCUSA shall be maintained by the sponsoring council. Such groups shall not hold property, and may not undertake any financial, legal, or contractual obligations, apart from their sponsoring council. They shall adhere to the sponsoring council's required policies on sexual misconduct, harassment, child and youth protection, and antiracism. Presbyteries shall determine appropriate means of representation and participation of such groups in and through the sponsoring councils (session and/or presbytery).

# Rationale:

- 1. The intention of the proposed amendment is to provide a minimal, flexible and adaptable, level of historic Reformed polity for small worshipping communities that wish to identify with the larger church in worship and formation, discipleship and mission. The wording is intended to be adaptable to current constitutional provisions and/or to whatever recommendations may emerge from the Task Force to Explore the Theology and Practice of Ordination.
- 2. There is currently no constitutional provision in The Book of Order of basic organizational guidance for small worshipping communities wishing to relate to the PCUSA, but not organized as a congregation. But, as is recognized in the establishment of the Task Force to Explore the Theology and Practice of Ordination, there is a broadly felt need for such.
- 3. From the PCUSA web-page on New Worshipping Communities: "Living out the Gospel demands ministry which engages today's cultures (John 1:14). New ways of joining Christians together for contextual ministry will use current and historic ways of "being church" as

springboards for creative innovation (Matt 9:17)." <a href="https://docs.google.com/file/d/0Bzgch04BtNAjblluaTFyZXczQWc/edit">https://docs.google.com/file/d/0Bzgch04BtNAjblluaTFyZXczQWc/edit</a>

- 4. From the PCUSA web-page on New Worshipping Communities: "As distinct yet connected expressions of the body of Christ, NWCs have local leadership arising from their own community of faith (Exodus 18:21). Pastoral leadership, facilities, and programs are all appropriately structured in order to demonstrate good and faithful stewardship." <a href="https://docs.google.com/file/d/08zgch04BtNAjblluaTFyZXczQWc/edit">https://docs.google.com/file/d/08zgch04BtNAjblluaTFyZXczQWc/edit</a>
- 5. This vision encompasses varying types of small worshipping communities, such as:
- a. New Worshipping Communities which are not at a place to be organized as congregations.
- b. Small churches no longer deemed viable or sustainable as organized congregations but which may be able to continue in ministry and service under sponsorship.
- c. Intentional small worshipping communities (fellowships, house churches, etc.) that desire to identify and be connected with the larger church without the burden of formal organization or legal incorporation.
- d. Groups with a particular need or emphasis (linguistic and cultural, minority, recovery, differently abled persons, residents of retirement communities, etc.) that wish to focus ministry on those needs as distinct worshipping communities, but also identify and be connected with the larger church.
- 6. The role of the sponsoring council (session or presbytery) would basically be that of an "umbrella organization" with oversight of financial, legal, and disciplinary matters as needed.

The principal body responsible for discerning the appropriateness of any such groups and their activities in relationship to the PCUSA would be the presbytery, in consultation with any sponsoring congregation, acting under the authority of Scripture, guided by The Book of Confessions, and governed by The Book of Order.

#### Sam Henderson: Faith Statement

I believe in God the Father, Son and Holy Spirit.

I believe God created the world and all that is and called it good. God created human women and men in God's image to share in the community, reflect the glory and live in the fellowship of the trinity.

I believe we humans have lost our way and thus fall short of the divine glory for which we were created. I believe the church discovers, shares in and continues Jesus' ministry as we witness to and foster the love and justice of God's kingdom for all, especially the lost, last and least. I believe the church is by its life to be a provisional demonstration of the kingdom of heaven, and that the truth of our proclamation is to be seen in our love for one another, and the hope and hospitality we demonstrate toward all.

I believe in the resurrection from the dead and life beyond this life. I believe Christ who came once as savior will come again as Lord of all, at which time all idolatries will be exposed and even "mustard seeds" of faith in God vindicated. I believe the mysteries of God's redemptive purposes will be revealed, that we shall see God face to face and that every knee will bow and every tongue confess that Jesus Christ is Lord to the glory of God the father. I believe that people from every race, tongue, tribe and nation will be united in proclaiming that salvation belongs to our God and to "the lamb who sits on the throne".

# Interim Pastor Agreement Between South Highland Presbyterian Church and

# Sam Henderson

(Guidelines Recommended for Use by Churches - rev. 2018=adapted)

(Note <u>Book of Order</u>, G-20504b. which states, "Temporary pastoral relationships are approved by the presbytery." The Presbytery of Sheppards and Lapsley Commission on Ministry has this responsibility.

The following agreement between South Highland Presbyterian Church (SHPC), and Sam Henderson (Witnessed and approved by the Presbytery of Sheppards and Lapsley COM) is for the purpose of providing part time (approximately 60% of full time) interim/transitional Ministry Leadership to SHPC.

# Broad Goals for this ministry include:

- 1. Maintenance of a healthy congregational life
- 2. Continuity of leadership
- 3. Continued development of congregational self-awareness, vision and missional priorities
- 4. Preparation of the congregation for the arrival of its next called Pastor/Head of Staff

#### The Interim Pastor and the Pastoral Search

It is understood by all parties to this covenant that the Interim Minister comes to do interim work, not to be a candidate for the vacant installed pastoral position, and, further, that the Congregation, through its Pastor Nominating Committee, assumes complete responsibility for the search for and calling of a Pastor. The Interim Pastor will have no role in suggesting or evaluating candidates.

The Interim Pastor will have no direct involvement with the Pastor Nominating Committee (PNC) or its pastor search. The Interim/ PNC relationship will be indirect, for administrative and communication purposes only. This indirect role will include such matters as, seeing that the PNC has and utilizes opportunities to make appropriate reports to appropriate bodies, as named below.

The Interim Pastor may, upon request (and in coordination with the Session, and/or the COM):

- be a mission study consultant in cooperation with the PNC and the presbytery liaison, documenting congregational conversations in ways that may serve the congregation, pastoral candidates, and/or future church leadership.
- serve as an adjunct consultant in adaptation of the Ministry Information Form
- will seek in every way to prepare the congregation for the coming of an installed Pastor.
- will make arrangements with the Pastor Nominating Committee for regular reports as needed to the Session, Congregation, and COM at appropriate times.
- Serve as an additional collegial reference for late-stage candidates, bearing witness to God's work in the congregation.
- The Interim Pastor will continue to be Pastor to the Pastor Nominating Committee Members.

## Agreement and Pastoral Work

The Interim work and Session governance will be carried out in partnership, with the Interim Pastor praying for, encouraging and supporting the work of the Session, and the Session praying for, supporting and encouraging the work of the Interim Pastor in all matters requested of him.

This agreement is for the period from January 15, 2024 until December 31, 2024, but is terminated when the called Pastor arrives. The agreement may be renewed for additional periods of time of up to twelve (12) months, which will also be terminated when the called Pastor arrives. If the called Pastor arrives or if the Session provides notice of termination of the relationship with the Interim Pastor before the agreement period ends, the contracted compensation will continue for an additional two (2) months beyond the notice of termination, or until the end of the agreement period, whichever is less. The Interim Pastor may be expected to and agrees to continue to serve the church during this period as determined by the Session. If the Interim Pastor terminates the contract before the Agreement period ends, compensation does not extend beyond the termination date.

The following agreement between the Session of South Highland Presbyterian Church and The Rev. Sam Henderson is for the purpose of providing part time (approximately 60% of full time) interim pastoral service to the Church during its search for an installed Pastor.

This agreement will begin on January 15, 2024 and will end on December 31, 2024.

#### THE INTERIM PASTOR:

Will not seek to become/is a member of this Presbytery.
Will be asked to serve as Moderator of the Session.
Will not assist in preparation of the Church Ministry Information Form.

All Ministry Work by the Interim.

#### THE BASIC AND ONGOING FUNCTIONS OF THIS MINISTRY WILL BE:

- 1. Lead worship and preach two Sundays out of four in a typical month.
- 2. Work with staff and lay leaders to facilitate needed caring ministries
- 3. Officiate at weddings and funerals as requested and available.
- 4. Plan and moderate Session and congregational meetings.
- 5. Work with committees to assist them in carrying out their assigned tasks.
- 6. Train newly-elected officers.
- 7. Perform other administrative and pastoral duties as requested.
- 8. Support colleagues and the Personnel Committee as a supportive interim Head of Staff

# THE SPECIALIZED FUNCTIONS OF THIS MINISTRY WILL BE:

- 1. Help this congregation examine their history and work through the grief process which usually follows the loss of a minister.
- 2. Enable the Session to identify and act appropriately on current opportunities and challenges.
- With a Session Task Group, lead Session and Congregation in a three-part mission study, as needed, with a final report available to the Congregation, PNC, pastoral candidates, and future leaders.
- 4. Help to Identify helpful pastoral qualities and congregational resources and commitments to partnership in a shared journey of faithful change with a next called Senior Pastor, as needed.
- 5. Examine linkage with Presbytery, Synod, and General Assembly, and identify resources that might be available from each of them.
- 6. Prepare the congregation for the arrival of a new minister.

POLICIES OF THE COMMISSION ON MINISTRY:

During the length of the agreement, the Interim Pastor will be accountable to this Presbytery through the Commission on Ministry (COM). A brief one-page report will be made to the COM on the status of the work at least quarterly. At the end of the agreement, the Session agrees to provide evaluation of the interim pastorate for the COM.

NOTE: When an Interim Associate Pastor is employed, appropriate changes in the wording of this agreement should be made, especially regarding the duties of the Minister. After the agreement is approved, any changes require the approval of the COM.

#### TERMS OF CALL:

If the Interim Pastor is employed on a part-time basis (approximately 60% of full time), appropriate compensation should be negotiated. Normally, the Interim Pastor will be compensated for interim pastoral services as follows (all amounts presented on annual basis):

Study Leave\*\*. Two weeks annually, pro-rated, including financial assistance consistent with the congregation's provision for the last installed Pastor, or according to Presbytery's standards. There will be no compensation for unused study leave.

Vacation\*\*. To be earned at a rate of one week per quarter and used or accumulated as agreed upon.

\*Professional Expense accounts are 100% available to the pastor as accountable reimbursement upon presentation of expense documentation, or as additional taxable income if no documentation is provided. If any professional expense account is exceeded for the year, that amount may be deducted from the pastor's taxable (W-2) salary for that year. Professional Allowance Accounts may flow into one another. Any documented overspending of the Professional Allowances annual or pro-rated total is subtracted from Salary and W-2. Any annual or pro-rated residual balances are paid as taxable income and are added to final W-2.

<sup>\*\*</sup> Four (4) vacation weeks and two (2) study leave weeks prorated for the portion of the year served. Unused vacation may be taken at end of covenant period.

Our 197th Memorial Day Celebration had about fifty attendees which is much less than previous years. Green Pond sponsors Mission Programs of our Presbytery, Synod and General Assembly offerings: PHFC; First Light, Living Waters for the World, Habitat for Humanity; participates in the Cents ability offering, One Great Hour of Sharing and Joy Gift. Locally, members prepare and deliver Wednesday lunches to 50 to 60 shut-ins in the community and provides school clothing and Christmas gifts to local children. Others in need are helped monetarily and with transportation. Secured leadership, arranged for and attended the annual CRE continuing education class with Dr. Joe Scrivner, Additionally, I read extensively in preparation for weekly sermons.
- 4. Robert Emerick CRE for Riverchase Presbyterian Church. Out a couple of weeks in November with knee replacement surgery. Three deaths in 2023 but membership remains steady. Substantial gifts from church friends keeps budget sound. Attended annual CRE training.

Pastoral care and visitations through letters and notes, telephone calls and emails in addition to face-to-face, home and hospital visits. Has published Volume I of his sermons, "Learning from the Lord; The Gospels. Volume 2 Acts Epistles -Revelation is currently under editorial revied by Christian Faith Publishing. Attended annual CRE training with Dr. Joe Scrivner in August. Also read Matthew Desmond's "Poverty, By America."
- 11. Frankie Tatus Created liturgies for bulletins and preached 34 times at FPC Anniston, Dodson Memorial, and Leeds Presbyterian. Officiates at communion on the first Sunday of each month at FPC Anniston. Assists Terry Tingle one Saturday a month receiving donations for PHFC.; Participated In the installation of Rev. Rachel Winter at Oakmont Presbyterian; Moderates the Administrative Commission of FPC Anniston and Moderator of their Session. This involves extensive time and duties. Auxiliary reading includes "Celtic Spiritualty, a daily devotional and two devotional studies by Jan Richardson.
- 12. Roger Thomas Has moved to Duncanville, Al (near Tuscaloosa) and is willing to supply in that area. Did not preach during 2023 during relocation and health problems of self and wife.

- 13. Lin Veazey Commissioned to Church of the Covenant in Anniston for past 12 years. Her 2023 work week is presently set at 15 hours for Covenant and five hours for First Presbyterian Jacksonville (moderate session for both churches) but is not representative of her workload which is more 20 hours for Covenant and ten for First Jacksonville. Along with sermons, weekly Bible study preparation, creating the bulletin and monthly newsletter, pastoral activities include visitation and counseling. # Caroline M. Kelly Faith Journey

My earliest memory of a relationship with God occurred around the time of my younger sister's birth. My parents would sit with my brother and me each night before bedtime, while we said our prayers. We would ask God to bless everyone and everything we could name and, in 1969, I added my petition for a sister. For my six-year-old self, my sister's birth on December 6, 1970, confirmed that God was real!

Though I was in church with my family every time the doors opened, it was not until an encounter with my grandmother when I was 17 that I began to understand how God was working in my life. During my last semester of high school, I was suspended for participating in an off-campus adventure that involved alcohol.

My parents responded to the news of my suspension as I expected, and I felt embarrassed and ashamed. However, my grandmother (who was the daughter of a Presbyterian minister) and who I assumed was straight as an arrow and would be angry with me, responded to my confession with laughter and a hug instead. I have carried that experience of God's grace with me ever since.

Had you asked me when I was a child what I wanted to be when I grew up, I would never have dreamed that I would become a Presbyterian pastor. I pursued a career in politics and then law before I discerned that God was calling me to something different. While I enjoyed the intellectual challenge and the opportunities to network with leaders in the community afforded me through the law firm, it did not take long to realize that it was not the environment in which I was going to thrive or, more importantly, use my skills in a way that would make a difference in the world.

I was not a leader at the law firm where I worked. When the real estate practice group would gather for lunch and share what we were working on, I was barely able to speak. I was a good advocate for my client on the phone in the privacy of my office, but a mess when it came to speaking in front of all the partners. And I was terrified of making a mistake.

God bless him, one of the younger partners took me under his wing. And while he didn't make me a great lawyer, God used him to launch me on the trajectory that brings me where I am today, another encounter I carry in my memory.

"Caroline," he said to me during one of my particularly anxious days, "there are very few mistakes you can make that can't be fixed. Don't forget that." Coming from someone who helped protect GE Capital's interest in some high-stake loans back in the 1990's, I found him very convincing. Again, a word of grace.

After that I started to trust my own judgment and intuition. I was skilled at listening to those around me and learning to live up to their expectations, so it took me a while to learn to hear God's voice. Eventually I heard that voice calling me to seminary.

Leaving my job and the security of a good salary was one of the hardest (but best) things I ever did. It was equally liberating and terrifying, the way I imagined it would feel to jump from an airplane and float weightlessly over a vast expanse of land with a whole new view of the world, but without a clue about how to land. That feeling, I decided, was a sign of the freedom proclaimed by the gospel.

After seminary, I stayed in Atlanta for 12 more years, serving at a downtown church across from the Georgia State Capitol where people experiencing homelessness and state legislators occupied the same

block. From there, I could see the building where I had practiced law, but it was altogether a different world. I was still using my advocacy skills, but for an altogether different purpose.

I am a fourth-generation Presbyterian pastor on my mother's side, steeped in the southern tradition but raised in a university church in Charlottesville, Virginia. Its dual mission serving university students and seeking social justice shaped my early understanding of the gospel as a means of drawing people into relationship with God and co-creating with God a world in which all people can flourish.

During my 23 years as a pastor, I have served churches located in downtown Atlanta, Western Maryland. and Central Kentucky. Having lived 21 years in Atlanta, including meeting and marrying my husband, Jim Mooney, there, I feel as though I am coming home, both geographically and theologically, to Grace. I am excited about being invited to share in ministry with a congregation that has a clear sense of identity and mission in the community - especially with those who have been excluded or harmed by the church — and look forward to offering my leadership to the next phase of its life as a congregation.



### **Executive Director's Corner**

Anniversaries are important. They are a time to look back and reminisce and a time to look forward to possibility. This year, Living River celebrates 2 very significant anniversaries. In 2004, the New Marvel Slab located at what is now the Williams Access to the Cahaba River was removed. In 2014, Living River was opened for business with infrastructure and buildings. The 20 years that the river has had to heal has brought significant restoration to the biodiversity of our stretch of the Cahaba. The 10 years of programming have brought a significant impact on the lives of individuals and groups who have benefited from the ability to retreat from the every day to learn, worship, and gather in this sacred place. Look out for more information about celebrating these milestones!

As we look forward, we do so with renewed energy. Our Living River Board of Directors met for an overnight retreat in January to participate in training on how to make strategic decisions for Living River's future. We sought to define our mission and vision and establish criteria for future decision-making to ensure that we live into our mission and vision as we grow.

As we begin 2024, we have 59 campers registered for Summer Camp, compared to 32 registered this time last year. We have 9 camp counselors either hired or in the process of being hired, compared to none this time last year. We have 12 weekends booked for rental groups between January and the beginning of Summer Camp. Our solar panels on the Dining Hall are generating power and saving money, thanks to First Presbyterian, Wetumpka. The Shades Valley Lodge renovation is 90% complete. And, we have received a grant from the Southminster Foundation for needed kitchen equipment. Thank you for your support! I would love to talk with you about how you can continue to support the mission of Living River. ### Report of the Mission Coordinator for Presbytery, February 2024

This is my report to the Presbytery. As usual, members and churches of this Presbytery are active in showing God's love.

- 1. The Birmingham area churches have completed the house construction in Pleasant Grove. This is the house sponsored by the Birmingham area churches in 2023. Contributions from area churches totaled about \$21,000. We will send \$20,000 to the Birmingham Habitat for Humanity. I will keep you informed about a possible house sponsorship for 2024. Also, do not forget that the Tuscaloosa chapter of Habitat for Humanity is very active in building houses. Ellen Potts is the Executive Director for the Tuscaloosa Habitat for Humanity.
- 2. We are planning to contribute \$1,500 to RECONCILE, from the Presbytery's Peacemaking Reserve. RECONCILE is an organization in South Sudan, working to reconcile groups that have fought each other. The Peacemaking Reserve is funded by contributions from Presbytery churches.
- 3. The Dallas County LTRG (Long Term Recovery Group) is working on various recovery projects in Selma and Dallas County. We have been attending the LTRG meetings and have contributed or committed money to four family projects. Three of these projects were to replace furniture and appliances for three families. We committed funds for the fourth project to help with the costs of building a 2-bedroom house. So far, this Presbytery has given or committed a total of \$12,345 for these projects. The money used has come from a \$7,500 grant from Presbyterian Disaster Assistance and \$4,845 from the Presbytery's Perry/Dallas County Fund. The Perry/Dallas County Fund was set up in 2017 to help combat poverty in the two counties. Churches contribute to the Fund. To donate, make a check out to Presbytery of Sheppards and Lapsley and, in the lower left corner, designate it for the Perry/Dallas County Fund. One may also donate to the Black Belt Community Foundation.
- 4. The Congo Mission Network will be holding its annual meeting at Charleston Atlantic Presbytery in North Charleston, SC on March 14-16. The meeting will be in-person and by Zoom. To register, please go to the Network's website: congopartners.org. The Network is comprised of churches and presbyteries around the US who are committed to working with our Presbyterian partners in the Democratic Republic of Congo. Our Presbytery has an active Congo Mission Team. Please join us.

# ADMINISTRATIVE COMMISSION – FPC, ANNISTON Report for Presbytery February 2023

16 Nov 2023	Presbytery met today at PHFC, Talladega. The proposal presented by the AC to approve the MOU between Community Foundation of NE Alabama and the church was approved, with 7 Nay votes.
15 Dec 2023	The deed for the FPC Anniston property was signed Dec. 14, 2023, completing the transaction making the CFNEA the new owner of the church property. Interviews are being arranged with Anniston publications to share the news of the FPC Anniston-CFNEA partnership.
	CFNEA and the Presbytery released a press release to Anniston outlets regarding the partnership between the Presbytery and CFNEA.
20 Dec 2023	Principals from the CFNEA, members of the FPC Anniston Session, and Moderator of the AC met with the Anniston Star reporters. The Star published an article, Dec. 20, 2023, to report on the partnership between the Presbytery and the CFNEA that would continue the legacy of the church while advancing the mission of the Presbytery.
21 Jan 2024	CEO of CFNEA Jennifer Maddox met with the congregation of FPC Anniston to outline plans for the partnership going forward. The stories of the church will be preserved; future changes to the building and grounds were discussed; and Ms Maddox invited the congregation to share their dreams and hopes for the future of the church.

### Report of the Administrative Commission Five Mile Presbyterian Church February 15, 2024

The Administrative Commission for Five Mile Presbyterian Church has not met since our last report, but work towards closing the church continues. The commission is charged with assisting the Session of Five Mile with the closing of the church. The final worship service was held on May 7, 2023. Members of the church have worshipped at Leeds PCUSA and Cahaba Springs PCUSA since that time.

Final legal documentation regarding the establishment of the Five Mile Foundation, a 501c3 entity charged with providing perpetual care for the historic sanctuary and cemetery had been completed. This work was begun by the Five Mile Session and approved by the congregation almost a decade ago. The last piece of that work involves replating the church property into two separate properties. Once that work is signed off on by governing municipalities, the separation will be complete.

At the August meeting or Presbytery, approval was given to the AC to deed the portion of the Five Mile property containing the cemetery and historic sanctuary to the Five Mile Foundation once the proper legal documentation is completed. As soon as that property separation takes place, the remaining property will be listed for sale. A contract offer for the remaining property has been received. It will be reviewed by the AC and Presbytery Trustees and hopefully presented for Presbytery approval at the May 2024 meeting.

Overture: Removal of investments in and subsidies for fossil fuels.

The Presbytery of Sheppards and Lapsley overtures the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to:

- 1. DECLARE that continued support of the exploration, development, funding, and exploitation of fossil fuels through investment of PC(USA) funds, violates the equitable welfare of all life and our biblical charge as humanity to care for creation, and is irretrievably incompatible with the mission and goals of the Presbyterian Church (U.S.A.).
- 2. DECLARE that all publicly traded companies whose primary source of income is derived from the exploration, development and production of fossil fuels are to be placed on the General Assembly's list of prohibited securities.
- 3. STRONGLY ENCOURAGE all congregations, presbyteries, synods, the Board of Pensions and the Presbyterian Foundation, as well as Church-related educational institutions and individual church members, to align their investment decisions with this declaration with all due speed and diligence.
- 4. CALL ON all PC(USA) members and institutional investors to seek out investments in clean renewable energy companies.
- 5. REQUEST reports from the Board of Pensions and the Presbyterian Foundation and other investing entities at the next General Assembly on the steps taken to align their investment decisions with the intent of this overture.
- 6. CALL ON the U.S. government to end all subsidies for the development and production of fossil fuels.

#### Rationale:

Our Values: Past General Assemblies have repeatedly stated the vocation of earth care as an essential mark of Christian discipleship and the Church's mission and ministry. Our responsibilities as a faith institution are clear: God created the earth, and it is sacred. The earth is the Lord's and all that is in it. We are a part of and not independent of the created order and are meant to be caretakers and protectors of creation and our neighbors.

Our Reality: We are in the midst of a climate crisis that is primarily caused by the production and burning of fossil fuels which release greenhouse gases, such as methane and carbon dioxide that are warming the planet. The scientific consensus, established over many years and with increasing levels of certitude, is that the

warming of our atmosphere beyond 1.5 degrees Celsius over pre-industrial temperatures will undermine the entire web of life on the planet with catastrophic consequences.

The Solution: In order to avoid this, the Intergovernmental (scientific) Panel on Climate Change (IPCC) reported in March 2023, that the nations of the world must cut our carbon emissions by 48% from 2019 levels by 2030 and reach net-zero carbon emissions by 2050, but last year, as in previous years, these emissions continued to climb. And while the U.S. has recently taken action to bring down its own emissions, we now produce and export more fossil fuels than ever in history. The U.S .also subsidizes the fossil fuel industry with estimates ranging from \$10-50 billion per year, while our northern neighbor, Canada and several other fossil fuel producing countries have announced that they are ending their subsidies.<sup>1</sup>

The world has to change the path it is on, but it requires two huge changes. The most critical change is a "fast, full and fair" phase out of fossil fuel production and usage. The second is the rapid expansion of sources of renewable energy. The church's investments have power and influence which can contribute to these changes and bear witness to the world that we acknowledge the climate crisis, the suffering it is causing and its link to the burning of fossil fuels.

The Denomination is Responding to the Climate Crisis: The Presbyterian Church (U.S.A.) has long recognized its obligation to take actions as faithful stewards of God's Creation to respond to climate change. The General Assembly actions in 1981, 1998, 1999, 2003, 2006, 2008, 2010, 2012, 2014, 2016, 2018 and 2022 acknowledge the realities of global warming and its effect on the "least of these" throughout our world.

The Mission Agency has raised the importance of earth care to a matter of high priority for every part of its programing and the work of our Presbyterian Hunger Program and Earth Care Congregations program are exemplary in their efforts to inform and lead the church in the fulfillment of its mission. In addition, our Office of Public Witness became a sponsor of an initiative, to be called the Fossil Fuel Non-proliferation Treaty, launched by the governments of several South Pacific island nations (among the most vulnerable of our brothers and sisters). This initiative is calling for the <u>phase-out</u> of both new and existing sources of fossil fuels.

The Denomination's Response is Inconsistent: Such educational and advocacy efforts on behalf of our denominational commitment to earth care are undermined by institutional strategies which continue to seek profit from investment in the fossil fuel industry. This practice is hypocritical at a minimum and potentially endangers our evangelistic message and leadership within the ecumenical community of church

bodies. While the percentage of total investments is small, (3.4% for The Foundation as of December 2023), the dollar value is in tens of millions of dollars. MRTI has begun a company by company divestment review, but the climate crisis is getting worse faster than our actions can bring about significant change.

Further, these PCUSA directed entities not only have a fiduciary duty to conserve and protect the church's assets and return an increase through the investment process, but are also obligated to duties of loyalty and obedience to our mission and established values to the extent allowed by secular law related to such.

Existing Policy Provides Option for Removal of Funds from an Entire Class of Firms: The original founding document from 1984 upon which our Mission Responsibility Through Investment (MRTI) is based, "Divestment Strategy: Principles and Criteria", clearly states that divestment of holdings can be in a particular "firm or class of firms" and that this is both part of the normal management of funds and potentially an occasion for Christian witness to God's call for justice and renewal of society. (Paragraph 25.202) It also states that divestment is a conscious decision to dispose of any current financial stake in an enterprise or 'class of enterprise' because of policy or practice in regard to a social issue and to prohibit future stake so long as the offending situation holds. (Paragraph 25.261) [emphasis and quotation marks added]"

Existing Policy also Provides for Proscription of a Class of Firms: Furthermore, that document identifies that there are some classes of investments which should not be considered because of their nature which is fundamentally and irretrievably incompatible with the nature and purpose of the church. Thus, there is a list of such classes of economic activity which are excluded or "proscribed". This list excludes from our investment portfolio, investment in companies whose primary activity is in production of tobacco products, nuclear weapons, for-profit prisons and a few others.

The Presbyterian Foundation is Moving in the Right Direction: The Presbyterian Church (U.S.A.) has a long history of aligning our corporate investment decisions with our values and enabling our members to do so. In fact, according to our Presbyterian Church Foundation's New Covenant Trust Company's website description for their "Fossil Free Strategy" they have established an instrument specifically "[f]or investors concerned with fossil fuel emissions and climate impact" which "can be configured to exclude the entire energy sector and other firms with a high carbon footprint."

The Path Forward for the Whole Denomination is Not Easy: We understand that the modern world and each of our lives are deeply intertwined with the fossil fuel industry and cannot be easily divorced from it. We live on the continuum between purity of moral conviction and the pragmatic exigencies of the current patterns and practices of the modern world. Yet we must act and act quickly, acknowledging the destructive nature of our fossil fuel investments.

In doing so, we refer the reader to the actions of our last General Assembly in support of communities where the loss of fossil fuel industry jobs will present hardship.

We Must Change: We understand and appreciate the role of our MRTI in encouraging enterprises to alter their practices to align more nearly with our values. However, we also know that there are some enterprises which are fundamentally such that no amount of change in practice will ever bring them into alignment. We feel it is past time for us to name the fossil fuel industry as one of these and existing policy provides for this.

For the sake of the integrity of our denomination's Christian witness, our purpose within the created order, the maintenance of the web of life upon which all humanity depends and our children's children, we must act quickly to withdraw all our resources, regardless of their size, either in dollar amount or percentage of those used, from the production of fossil fuels and to identify fossil fuels as a proscribed class of investments.

## THE PRESBYTERY OF SHEPPARDS & LAPSLEY FINANCE REPORT FOR 2023

The year 2023 was a fairly stable, uneventful financial year for the Presbytery of Sheppards & Lapsley. Let us start with:

#### **OPERATING INCOME-**

Actual revenues were \$460,060 or (\$13,416) less than plan of \$473,476. This revenue reduction resulted from a combination of a reductions - (\$14,640) in Per Capita Income, a (\$8,926) reduction in Mission Giving accounts, and a (\$4,369) in Birmingham UKirk revenues. Partially offsetting these reduced revenues were unbudgeted lease revenues of \$17,605.

Operating Expenses were \$474,509 or right in line with the plan of \$473,477. Total Council Expenses were higher than plan by (\$8,757) but were offset by lower ENC expenses, which were \$12,185 better than plan.

Operating net income at Year End 2023 was a loss of (\$14,449) due primarily to the lower revenues mentioned above.

### **OTHER REVENUES AND EXPENSES-**

Below Operating revenues and expenses are Other Revenues of \$30,147 in Notes Receivables interest and \$24,747 in Investment income revenues. Year-end Investments balance was \$1,109,179. Other expenses included Legal fees of \$570 and Living River donations of \$33,515.

Adding this Other income and expenses to Operating Income nets a total bottom line of \$6,360.

During 2023, as we do every year, our finance group also updated Appendix II of the Standing Rules, the Manual of Financial and Accounting Procedures. We looked at the original purpose and history of our restricted funds to identify which funds, based on their original intent and history, could be available for Presbytery growth needs.
