
Strategic Goals for 2025 that were approved by the executive council include the following action items.

# SYNOD OF LIVING WATERS 2025 ANNUAL MEETING January 27, 2025 at First Presbyterian Church, Franklin, TN

The meeting was called to order with prayer by the Moderator, the Rev. Dr. Ann Laird Jones. Worship and the Sacrament of the Lord's Supper was led by the Rev. Dr. Victor Aloyo, President of Columbia Theological Seminary, preaching. Dr. Aloyo brought an inspiring sermon about the power of the Holy Spirit working in our congregations today in many and different ways.

Stewardship as Mission" was presented by Rev. Dana Waters, Ministry Relations Officer with the Presbyterian Foundation. Dana made the facts and figures come alive for those of us in attendance! He focused on "Cultivating Generosity in the Church" through telling our stories, giving interesting suggestions for successful outcomes, reaching beyond the often mundane discipline commonly named "stewardship" in the church. He included helpful checklists for telling our stories well, ways to make it easy for people to give, keys to success, budget best practices, and starting a Legacy Giving Program. We have secured a copy of Dana's power point slide presentation which will be available from the Presbytery Office. We encourage all sessions and congregations to use this presentation in planning for generous giving in your churches. Even better, invite Dana to present this workshop in person to your congregation - it will be well-worth the time!

The second workshop, "Disaster Preparedness", was presented by Rev. Nell M. Herring, Associate for Volunteer Ministries of Presbyterian Disaster Assistance. (Report from Judith Baldwin)

The business meeting portion of the day began with greetings form General Assembly Entity Representatives:

- Keenan Rodgers and Clark Simmons, Board of Pensions: Highlighted a Shared Ministry Program to ease the transition in dues for small churches over a five-year period, and a new mental health association with "no dues on dues" for Presbyters and Stated Clerks.
- Lauren Rogers, PCUSA: There will be a reduction in the number of special offerings in 2026 from four down to three.
- Tanner Pickett, Montreat Conference Center: After the hurricane damage, regular programming has resumed; prayers and donations are still needed as they work with a long-term recovery group.

### And from Covenant Partners:

- Rev. Julie Bailey, Columbia Theological Seminary: Ministry to students focusing on trauma counseling.
- Doug Marshall, Presbyterian Home for Children: Caminos program for refugee resettlement; Union Village for deaf and blind.
- Rev. Beatrix Weil, Rhodes College: Interfaith conversations about democracy.

- Dr. Burton Webb, University of Pikeville: Established a dental school in Eastern, KY; Work has begun on a wellness clinic and athletic park on campus.
- Kathleen Farnham, Maryville College: 1<sup>st</sup> college in America (50 years) teaching American Sign Language which is now recognized as a high school language choice in TN.
- Dr. Mark McCormick, Stillman College: Class exchange with University of Alabama; Host for the Congo Mission Conference in October.

### Reports of Officers and Entities:

- Moderator, Rev. Dr. Ann Laird Jones:
  - o Lifted up the Virtual Voice focus on "Recovery, Restoration, and Rebirth".
  - O Virtual Voice is looking for reporters from each presbytery.

- Financial Administrator, Vicki Schramm: the 2024 end of the year financial report was received.
- Presbyterian Women, Rev. Kirsten King:
  - o Over 800 attended the Churchwide Gathering in St. Louis, MO.
  - Mission Haven, established in 1951 jointly by the Synod of Living Waters and the Synod of South Atlantic, may face some changes due to cut-backs on mission workers.
  - o 2025 Triennial Gathering at St. Simon's Island, GA will be a joint meeting of the two synods on October 17-19, 2025.
- Living Waters for the World, Steve Young:
  - o 32 years, 2600 people trained by CWU, 1100 communities in 28 nations served.

  - o Adoption of the 2025 Synod Budget, including a 2 ½% increase in staff salaries.

### Stated Clerk's Report

January 27, 2025

### Items for Information

- 1. There was one remedial complaint filed in 2024. Following the preliminary ruling issued by the synod's permanent judicial commission officers, the complaint was withdrawn by the complainant.
- 2. The Synod's 2022 and 2023 minutes have been reviewed by the General Assembly and approved without exception.
- 3. The Administrative Board (Board) took the following actions at its meetings during 2024:
  - At its meeting on April 11, 2024, the Board approved inviting Dr. Victor Aloyo to preach at the opening worship service of the synod's 2025 annual meeting.
  - Also at the April 11 meeting, the Board endorsed a collaborative partnership between the Synod and Presbyterian Disaster Assistance to work in the long term recovery process in Haiti.
  - At its meeting on July 10, 2024, the Board endorsed a Presbyterian Investment and Loan Program (PILP) loan to Springdale Presbyterian Church in Louisville, KY and approved designating up to \$120,000 of its funds invested in PILP for a line of credit that the Buckhorn Home for Children has requested for a "bridge loan" until their federal funding is processed. This designation results in a 1% reduction in the loan rate they are charged.
  - At the July 10, 2024 meeting the Board also approved holding the January 27, 2025 annual meeting of the synod at First Presbyterian Church, Franklin, pending sessional approval.
  - At the October 17, 2024 meeting the Board approved a \$2,500 sponsorship of the Association of Partners in Christian Education (APCE) event that will be held in Memphis TN in January 2025.
  - At its December 5, 2024 meeting the Board authorized the establishment of a
    transitional ministry training program in the synod, with a planning team
    composed of James Gale, Wendy Neff, Anne McKee, and Ann Laird Jones, with
    Greg Goodwiller serving as staff. It is understood that the planning team will
    develop a budget including funding needs for presentation to the Board at a future
    meeting.
  - At its December 5, 2024 meeting the Board approved a proposed 2025 budget to recommend for adoption by the synod at its annual meeting, and approved the

recommendation of the Personnel Committee that Greg Goodwiller be elected for an initial three year term as Stated Clerk as presented by the Board in its report.

Report of the General Presbyter of the Presbytery of Sheppards and Lapsley February 2025

January is a month of the "changing of the guard" as our committees and commissions welcome new members and, in some cases, elect new moderators. It is a transitional month and I am pleased to report that our presbytery commissions and committees are now up and running to serve the mission of the presbytery. Thank you to all who have said yes to these leadership positions!

In the vein of transitions, at the presbytery meeting in February, we will have the pleasure of thanking our moderator, Deborah Thomas, for her steady hand guiding our work together in 2024. At the conclusion of her Moderator-of-the Presbytery duties, she will spend another year moderating our Executive Council. Meanwhile, we will install our 2025 Moderator, Jonathan Yarboro and vice-moderator, Terry Hamilton-Poore. We are blessed to have such talented and willing leaders!

At the November presbytery meeting, the presbytery created the "New Commission" which is a commission to determine guidelines and processes for congregations to receive funding from the new fund we have developed from the 70% of the proceeds from the sale of church buildings dedicated to the mission of local congregations. By the time of the presbytery meeting, this new commission, moderated by Joe Genau, will have met and be up and running. Stay tuned for developments.

And still in the realm of transitions, with the election of the final nominees at this presbytery meeting, the Transition Team will begin its work. As you recall, the Transition Team (which will elect its moderator at its first meeting) is charged with:

- Conducting a thorough mission study on the presbytery including staffing models, office procedures, committee/commission structure and function, and bylaws as necessary.
- Writing a Ministry Discernment Profile for the presbytery's approval
- Conducting a national search for a new presbytery leader(s)
- Presenting the candidate(s) for presbytery approval with a hoped for start date of February 2026.

The Transition Team will work with due haste yet do their work thoughtfully and deliberately with the luxury of having Jay Wilkins and myself still very much serving the presbytery until the new leadership is in place.

We have an exciting year ahead of us as we faithfully live out our Matthew 25 mission to "Partner with and equip present and emerging PC (USA) faith communities in central Alabama to serve Christ and our neighbors".

## Presbytery of Sheppards and Lapsley 2025 Minimum Terms of Call

### INTRODUCTION

### **Foundation**

In preparation for revising the Minimum Terms of Call for Sheppards and Lapsley, the Commission on Ministry was mindful of the sacred obligations of each congregation to care for their pastor(s) and the duty of the Presbytery, through the COM, to review and consent to all Terms of Call within our bounds. Among those obligations and duties, the following best illustrate the rationale for revision:

- The obligation of each congregation to provide "all proper support, encouragement and allegiance in the Lord" so that their pastor(s) may concentrate on their ministry.
- The unified voice of a congregation as they "promise to pay [the pastor] fairly and provide for their welfare..." and "to stand by them in trouble and share their joys."<sup>2</sup>
- The duty of Presbytery (through COM) that "terms of call shall always meet or exceed any minimum requirement of the presbytery in effect when the call is made."<sup>3</sup>

### **Three-way Contract**

The terms of pastoral call to a church require the approval of the congregation calling, the minister being called, and the Presbytery (through its Commission on Ministry). Once established, any change in the terms of call likewise requires the approval of all three parties.

### **Annual review by Session**

"The Session shall review annually the minister's terms of call and shall propose for congregational action (BO G-1.0501) such changes as the session deems appropriate, provided that they meet the Presbytery's minimum requirements." Any reduction in effective salary must receive approval of the Commission on Ministry before payments are changed and must also be approved by the Presbytery with the Annual Approval of Terms of Call. Bonuses and gifts paid by the church exceeding 20% of effective salary must receive prior approval by the presbytery.

### Annual cost of living consideration

In keeping with the annual review, sessions are urged to consider both merit increases and annual cost of living adjustments, mindful that less than the COLA represents a reduction of salary in terms of buying power.

### **Board of Pensions consideration**

2025 brings new coverage options for medical coverage with potential impact to pastor, pastor's family, and the church. In revising the Minimum Terms of Call, the Commission on Ministry has considered the possible impact of these changes and weighed them against our Foundational Obligations.

### MINIMUM TERMS OF CALL FOR FULL TIME MINISTERS

"The terms of call shall always meet or exceed any minimum requirement of the Presbytery in effect when the call is made." (BO G-2.0804)

### **Minimum CASH and EFFECTIVE salary**

The minimum terms of Pastor's Annual Cash Salary plus Pastor's Housing Allowance (if any), for all new, installed calls and all revised calls shall be **no less than \$46,000**. Please review the Effective Salary Worksheet when calculating compensation for a specific pastor's terms of call.

### Required components of compensation

The pastoral compensation and benefits package *shall include at a minimum all of the following components*:

- 1. Pastor's Cash Salary
- 2. Pastor's Housing Allowance, if selected by the pastor (The sum of #1 and #2 being no less than \$46,000.)
- 3. Board of Pensions Dues for Pension, Death and Disability, and 100% of the medical premium of the pastor. (The dues for 2025 equal 26% of effective salary.)
- 4. The calling church shall ensure that the pastor's spouse, children, or family [spouse + children] are covered by medical insurance. If the calling church does not provide said insurance, an explanation of how the pastor's family is covered by medical insurance shall be included as part of the Terms of Call.
- 5. \$4,000 per year Accountable Reimbursement Plan for Professional Expenses such as mileage & travel expenses, continuing education, books

### Additional (non-mandatory) components of compensation

The minimum pastoral salary, compensation, and benefits package *may include some or all of the following*:

- 1. SECA (Employer pays first 7.65% of Total Effective Salary. If employer pays more, the additional amount is taxable to the employee as part of cash salary)
- 2. Accountable Auto Expense Reimbursement Account, miles driven reimbursable per mile using current IRS guidelines
- 3. Moving Expenses (Please note that moving expenses are taxable by the federal government as part of the pastor's salary)
- 4. 403(b) Non-profit Retirement Savings Account with or without employer matching
- 5. Health Care Flexible Spending Accounts
- 6. Dental Insurance
- 7. Vision Insurance

(The above list is not meant to be an exhaustive list of possible ways to compensate your pastor. Some of these components may be taxable to the pastor.)

### Minimum TOTAL COST of compensation package

The total of all salary, compensation, and benefits components negotiated between the pastor and the congregation *shall total no less than \$63,000*. This is greater than the sum of the minimum components. The congregation and pastor should work together to ensure that the overall minimum requirement is met in a fashion mutually beneficial to both parties.

### **ADDITIONAL required minimum benefits**

The following shall be part of each pastor's terms of call:

- Four (4) weeks vacation (inclusive of 4 Sundays) per year
- Two (2) weeks continuing education leave (inclusive of 2 Sundays) per year
- 12-weeks parental leave per presbytery Parental Leave policy
- Sabbatical Leave per presbytery sabbatical leave policy

### CALL TERMINOLOGY

### **Anti-racism Training**

All Ministers of the Word and Sacrament who are serving as pastors of a congregation are required to participate in a training program organized by the Anti-racism Committee at least once every three years. Additional information may be found in the Presbytery of Sheppards and Lapsley Policy on Racism and Training Prepared by the Anti-Racism Committee.

### **Board of Pensions Dues**

"The call shall include participation in the benefits plan of the Presbyterian Church (USA), including both pension and medical coverage" (BO G-2.0804). The 2025 BOP dues for pastor only (not including spouse, children, or family coverage) are 26% of the total effective salary.

### **Continuing Education and Study Leave**

Two weeks shall be allowed each year in the terms of call for continuing education or independent study provided it is used for that purpose. It is not to be regarded as additional vacation.

### **Healthy Boundaries Training**

Healthy boundaries training is required every three years for all minister members of the presbytery.

### **Housing Allowance**

In lieu of a manse, the call shall include a housing allowance sufficient to provide a home. To satisfy IRS requirements, any portion of the salary designated as housing allowance must be approved by the congregation prior to payment. To facilitate this requirement, sessions should take action on any proposed change in the housing allowance prior to the end of the tax year.

### **Medical Insurance**

Medical insurance (or health insurance) is insurance that satisfies the Minimum Essential Coverage requirements of the Afffordable Care Act.

### **Moving Expenses**

The calling Church pays for or reimburses pastor for reasonable moving expenses incurred.

### **Parental and Family Leave**

Guidance on parental and family leave can be found in the following policy on the Presbytery web site: Presbytery of Sheppards and Lapsley Parental and Family Leave Recommendations for Ministers of Word and Sacrament, Commissioned Ruling Elders, Certified Christian Educators.

### **Professional Expenses**

While specific amounts may be part of the call, it is advantageous to the pastor to have this in a designated "Accountable Reimbursement Plan" whereby the minister is reimbursed for substantiated documented expenses (auto, travel, continuing education events, books, etc.). These expenses are thereby not included in reportable income for IRS purposes. A minimum allocated by the church should be \$4,000.

### Sabbatical

A Sabbatical Leave of at least three months after six years of service to an individual church is recommended and must be considered as part of the pastor's annual review of terms of call. Any congregation unable to implement a Sabbatical Leave plan within the guidelines of the Presbytery policy shall provide a written rationale to the COM along with the present terms of call.

### **Sick Leave**

For his or her own care and that of others, the pastor is not expected to work when sick. Illness lasting more than a week shall be considered by the Personnel Committee, and any recommendations referred to the Session for information and/or action.

### Social Security<sup>5</sup>

The call shall include a reimbursement of at least 50% of the SECA obligation.

### Vacation

The call shall include four weeks of vacation each year (initially prorated in the first year of employment based on the beginning of service).

<sup>&</sup>lt;sup>5</sup> Ministers called by congregations are considered by the IRS to be "employees" for federal income tax purposes but "self-employed" for purposes of social security taxation and are required to pay quarterly estimated Federal income taxes and SECA taxes. Hence ministers pay the full 15.3% for social security coverage. Since employed persons pay only one-half of that, the policy of Presbytery is to include a reimbursement by the church of half (7.65%) of the SECA tax in the terms of call.

### OTHER CONCERNS

### Extra time away

Pastor's time away beyond vacation and study leave is to be determined by agreement between the session and the minister.

### Presbytery participation and relationship

Pastors are presbyters, and vow to "be active in government and discipline, serving in the councils of the church," to "be a friend among ... colleagues in ministry, working with them, subject to the ordering of God's Word and Spirit." (BO W-4.003i, W-4.003e)

### **Part Time Pastors**

The salary of part time pastors working at least 20 hours per week is prorated accordingly. Vacation and study leave remain the same as for full time pastors. For Board of Pension dues for a part time installed pastor, consult the presbytery Stated Clerk.

### **Temporary Pastors**

Temporary pastors working less than 20 hours per week are not covered by the Board of Pensions, and are paid in accordance with hours worked. Those working at least 20 hours per week may be provided benefits through the Board of Pensions.

### **Pulpit Supply Recommendations**

Persons serving in a pulpit supply relationship are paid an honorarium of at least \$175 per Sunday plus mileage at the current IRS rate. A Presbytery appointed Session Moderator should be paid \$50 per stated meeting. Mileage at the current IRS rate should also be paid if the Moderator travels to the location for Session meeting only.

### **Termination**

### Procedure

"An installed pastoral relationship may be dissolved only by the presbytery. Whether the teaching elder, the congregation, or the presbytery initiates the proceedings for dissolution of the relationship, there shall always be a meeting of the congregation to consider the matter and to consent, or decline to consent to dissolution." (BO G-2.09)

#### Severance provisions

When the congregation initiates the termination, the pastor, congregation and Presbytery will negotiate a severance agreement consisting of three to six months continuation of the terms of call in effect at the time of dissolution of the pastoral relationship. If the pastor begins a new call the severance pay may cease.

# Request to Transfer Ministry

The Session of Dodson Memorial Presbyterian Church, Oxford, AL hereby request the transfer of the ministry of *Trail Chaplain to the Alabama Pinhoti Trail* from a validated ministry of the Presbytery to a ministry of Dodson Memorial Presbyterian Church.

### **Rationale**

- Oxford is located close to the half-way point of the approx. 180-mile-long Alabama Pinhoti Trail.
- The Section closest to Oxford is also the busiest section by far. Section 6 runs through the Cheaha Wilderness Area and through part of Cheaha State Park. These public lands attract a substantial number of visitors from the Birmingham and Atlanta MSAs and from around the US and beyond.
- In the 2023/2024 season, worship services using the name "Church on the Pinhoti" were conducted at various locations along the trail. These services were well attended and attracted a diverse group of participants. Given the length of the trail, some participants could not attend all the worship services because of the distance. The plan for the 2024/2025 season is to target the worship services to a more focused area in the hope of gathering a regular group of worshippers. If the Holy Spirit is willing, the next step would be to encourage the formation of a New Worshipping Community.
- Dodson Memorial Presbyterian Church continues to explore innovative ways to ensure our ministry to this community since the 1850s is sustainable for future generations. Some of the options being explored, such as a dedicated monthly Iona Service and Earth Care ministries, would be relevant to any New Worshipping Community.
- The Trail Chaplain is also the CRE who leads regular weekly worship at Dodson.
- Regular contact with the Session at Dodson enhances the level of accountability to the Trail Chaplain.

### If the request is granted:

- The Trail Chaplain and associated ministries will become ministries of Dodson Memorial Presbyterian Church.
- The Trail Chaplain continues to be a volunteer role.
- The Trail Chaplain will continue to bring a ministry of presence to the entire length of the Alabama portion of the trail through section-hiking the whole trail in the fall and spring and will respond to issues as they arise.
- The Trail Chaplain is accountable to the Session of Dodson Memorial Presbyterian Church.
- This arrangement will be reviewed annually.

### **Norman Hibbard Memorial**

Rev. Caroline Kelly, Grace, Tuscaloosa, offered some words in memory of Rev. Norman Hibbard, who died in December of 2024.

After his ordination to the Ministry of Word and Sacrament, Rev. Hibbard served as an interim/transitional pastor for congregations in Florida, Alaska, Alabama, Indiana, Louisiana, and Mississippi. He graduated Columbia Theological Seminary as a second career student in 1982 (after 25 years of owning a concrete business in Tuscaloosa). He took Alban Institute training for interim specialists and later did a DMin at San Francisco Theological Seminary.

Norman was adept at reading local contexts and helping congregations work through conflicts. An avid traveler, he and his wife Helene Hibbard were good at developing respectful cross-cultural relationships. He walked the talk of loving God and others as himself.

Prior to seminary Norman and his wife were active leaders in youth programs at Covenant Presbyterian in Tuscaloosa and in children and youth programs in this Presbytery. He was served as a deacon and a ruling elder at Covenant, one of the churches that merged in 2017 to form Grace.

I'm glad to share a few words about Rev. Hibbard as a person of faith and a servant of the church.

# Mission Coordinator's Report to Presbytery February 20, 2025

- 1. The Presbytery will be hosting the annual meeting of the Congo Mission Network in Tuscaloosa, October 23-25, 2025. Planning for the Conference is underway. It is planned for the meeting to be hybrid, with both in person sessions and Zoom. French-English translation will be provided. Please plan on attending this Conference. Presbyterians from central Alabama, William Sheppard and Samuel Lapsley, were the first Presbyterian missionaries to Congo in 1891. We have a long history with the Congo church in service to our Lord, Jesus Christ.
- 2. This Presbytery has sent \$1,500 to RECONCILE, a peacemaking ministry in South Sudan. We have been sending our Peacemaking Offering money to RECONCILE for the past several years.

Reverend Shelvis and Reverend Nancy Smith-Mather have been working with RECONCILE for several years, working in South Sudan. They are now in the United States, but are still involved with RECONCILE. RECONCILE works on reconciliation between ethnic groups that had been fighting. It has offered trainings and counseling in conflict zones for 750 leaders in the past year. Also, RECONCILE operated sports tournaments aimed at establishing trust and confidence among eight different communities, with over 1,000 people attending. These are only a portion of RECONCILE's work in 2024.



- 3. The Habitat for Humanity house for the Birmingham area for 2024 has been built. We collected about \$18,000 for the house from Birmingham area churches. This will be sent to Habitat for Humanity, Birmingham. Our donations were down from the past couple of years. The donations had been running \$20,000-25,000. Thank you to all the churches and volunteers who helped a family get an affordable house.
- 4. Presbytery will be sending \$5,000 to the Dallas County Long Term Recovery Group to help build a house in Selma. This house is a rebuild of a family's house that was destroyed in the tornado of 2023. Over the past two years, this Presbytery has contributed about \$45,000 to help 7 families in Selma, replacing appliances, furniture and building houses.

# **Living River's Impact**

- Living River served over 390 kids and youth in 2024:
  - Living River's retreats and Summer Camp served 195 kids and youth.
  - Field trips served 199 kids and youth.
- The second annual Cahaba Lily Adult Retreat drew a diversity of longtime Living River friends and first-time visitors. Join others this May for an adult retreat and visit to the Cahaba Lilies.
- Over 200 visitors participated in Fall River Fest again in 2024 and enjoyed a variety of activities from an Alabama Wildlife Center animal show to a commemoration of the 20th anniversary of the Marvel Slab Dam removal from the Cahaba with a number of environmental partners.
- A diversity of rental groups booked and enjoyed 37 weekends at Living River with many more.
- The University of Alabama Atkinson Mussel Lab, the Alabama Aquatic Biodiversity Center, and the U.S. Fish and Wildlife Services continued monitoring and testing species and Cahaba Riverkeeper continued regular water testing.





#### Dear Friends in Christ:

We are incredibly grateful to the Presbytery of Sheppards and Lapsley for your prayers, encouragement and support of the Presbyterian Home for Children. For 157 years, we have been caring for at-risk and homeless children and families from across Alabama at a faith-based safe haven where we can nurture, educate and equip children, youth, young adults and moms in need to become the fully functioning persons whom God created them to be. Because of you and others in Alabama, the rest of the Synod of Living Waters, and beyond – together in a shared calling – the Home continues to provide healing and love on a path of hope so these precious ones can have a safe and secure future. Thanks to our donors, this recent Christmas season was truly a special and wonderful time for the children, youth and individuals served by the Home.

Our Board and Staff are very excited about the latest developments happening on and off campus. We completed renovations of two cottages on our historic campus to open up more long-term transitional housing with full wrap-around program support on campus for homeless moms with children in our Secure Dwellings program. Renovations of Whitfield and Robinson Cottages have put us in a position to double capacity for moms and children in need in our Secure Dwellings program, which is our core ministry in Talladega. More of these families in need can be referred from churches and presbyteries in Alabama, Tennessee, Mississippi and Kentucky as a result of our covenant agreement with the Synod of Living Waters.

We also have a nearly full roster in our Transition to Adult Living program, which provides long-term transitional housing to young female adults aged 19-24 in another historic building on our Talladega campus, Johnson Hall. These young women are also referred by our church relationships.

Our Caminos® program launched in 2024 to serve unaccompanied immigrant minors living in Alabama, the Southeast and beyond with both home studies and case management services to help provide family reunification and protection for these minors from abuse, exploitation and trafficking. We are also thrilled to have our Caminos® office located at the Presbytery of Sheppards and Lapsley office in Birmingham with the best neighbors ever.

Our innovative Family Bridges program is growing again. The State of Alabama Department of Human Resources recently awarded the Home an expanded contract that allows the program to serve 16 families in need in East Central Alabama, a growth of 23%. As the need arises, the Home will be hiring an additional family support specialist.

The second semester for Ascension Leadership Academy has begun. Ascension, located at First Presbyterian Church of Talladega, is where we provide a personalized learning environment for K-12 students from our Secure Dwellings program in addition to students from the community. During 2024, Ascension achieved reaccreditation through 2030 from Cognia through a very rigorous

evaluation process. Ascension received a score of 326 on Cognia's Index of Educational Quality. A score above 300 indicates the institution meets Cognia's expectations for accreditation. Ascension also scored 100 points above the national average of 253. Ninety percent of Ascension's standards rated above the network average, and the school's rating on the summaries for each of the four Key Characteristics exceeded the Cognia Network average.

The Home also grew its outreach mission ministry in 2024 in partnership with a small nonprofit serving children in poverty in Pine Hill, Alabama. The Home, along with M.I.N.D. Mentoring in New Dimensions, started a Weekend Backpack program in September that sends two meals and healthy snacks home with 40 children in the most need at FS Ervin Elementary School in the Wilcox County Schools system every week. It is part of an effort to expand our impact on children and families living in poverty in the poorest region in Alabama located three hours from our Talladega campus.

We are so appreciative of two large gifts from within the Presbytery of Sheppards and Lapsley: \$280,000 over three years from the Calhoun Presbyterian Foundation for deferred maintenance on our historic campus and \$300,000 from Second Presbyterian Church for a new duplex now under construction at Union Village, our permanent supportive housing community with full wrap-around program support from the Alabama Institute for Deaf and Blind for adults who are deaf, blind, deafblind and multi-disabled. Both of these gifts will greatly expand our ability to serve vulnerable individuals entrusted to our care.

Since 2017, the Presbyterian Home for Children has held the highest standard for a faith-based organization, the EAGLE accreditation. We were reaccredited for the prestigious honor in 2020. Since accreditation is renewed on a four-year cycle, it's that time again for PHFC to go through the process to keep our honored accreditation status with Educational Assessment Guidelines Leading toward Excellence (EAGLE), the only faith-based accrediting body in the United States for ministry to children and older adults. 2025 will be a busy year as our staff continue to prepare for the arduous documentation to maintain the accreditation title. We go through this process because EAGLE focuses on the organization's long-term sustainability and establishes responsible stewardship over physical and financial assets. Other accreditation agencies do the same thing, but EAGLE also assures the organization is operating in a manner that is representative of their faith foundation. EAGLE challenges organizations not just to compete in a challenging human services environment, but to soar above the competition while living their faith values.

As President, I feel like a mirror reflecting the love, compassion, and professionalism of our amazing Board and Staff.

# THE PRESBYTERY OF SHEPPARDS & LAPSLEY FINANCE REPORT FOR 2024

The year 2024 was a fairly stable financial year for the Presbytery of Sheppards & Lapsley. Let us start with:

### **OPERATING INCOME-**

Actual revenues were \$459,149 or (\$9,130) less than plan of \$468,279. This revenue reduction resulted from a combination of a reductions - (\$19,554) in Per Capita Income, a (\$11,707) reduction in Mission Giving accounts, and (\$20,419) in reduced Birmingham UKirk revenues. Mostly offsetting these reduced revenues were unbudgeted lease revenues of \$14,175 and Closed church operating giving of \$21,350.

Operating Expenses were \$462,966 or less than the plan of \$471,209 by \$8,243. Total Council Expenses were in line with than plan but were offset by lower ENC expenses, which were \$7,677 better than plan.

Operating net income at Year End 2024 was a loss of (\$3,817) compared to a planned loss of (\$2,930).

### OTHER REVENUES AND EXPENSES-

Below Operating revenues and expenses are Other Revenues of \$29,682 in Notes Receivables interest and \$87,234 in Investment income revenues. Due to the sale of churches, a gain on Property Contribution was \$117,900. Year-end Investments balance was \$1,261,765. Other expenses included Living River donations of \$33,515.

Adding this Other income and expenses to Operating Income nets a total bottom line income of \$197,486.

During 2024, as we do every year, our finance group also updated Appendix II of the Standing Rules, the Manual of Financial and Accounting Procedures. We looked at the original purpose and history of our restricted funds to identify which funds, based on their original intent and history, could be available for Presbytery growth needs.



# **Shared Ministry Program**

The new Shared Ministry Program encourages two or more Presbyterian Church (U.S.A.) congregations to covenant to create sustainable pastoral positions for ordained ministers. Participating congregations enter into a five-year dues subsidy program with the Board to receive a subsidy of the cost of benefits for pastors. Shared Ministry is <u>not</u> a merger of churches; rather, it is multiple, individual congregations sharing a minister with a living wage and benefits that helps ministry flourish and be sustained for the long term. <u>Learn more about the program</u>, including key considerations and how to get started.

# **Assistance Program Updates**

As part of our commitment to mutual care and wholeness, the Board of Pensions continues to expand access to grants through the Assistance Program to serve more ministers, employees, retirees, and surviving spouses who have financial need. In 2024, the Assistance Program distributed over 2,500 grants for a total of approximately \$8.5 million in funds. Read about potential grant opportunities.

- 3. **Per Capita** Of the \$199,233.00 budgeted for 2024, \$190,527.68 was received from 51 out of 57 Churches. Many thanks to those who have supported Per Capita! Much encouragement to those who have yet to give!
  - Our Per Capita Assessment for 2025 is \$28.42. Of this \$10.84 goes to the General Assembly; \$3.98 to the Synod of Living Waters; \$12.60 to the Presbytery of Sheppards and Lapsley; and \$1.00 to Campus Ministry.
- 4. The Stated Clerk continues implementing the **Background Check** requirement of our Child and Youth Protection Policy which requires background checks to be run every three years. The only exemption is for those who are no longer engaged in ministry or who have had a check within the last three (3) years. Please contact the Stated Clerk with any questions or concerns. The Stated Clerk is also tracking participation in **anti racism and boundary training** which are now required by the Book of Order G-3.0106

# Administrative Commission Report to Presbytery Providence AC February 20, 2025

The Providence Presbyterian Church Administrative Commission had its first meeting October 31, 2024. Rev. Jonathan Yarboro was elected Chair of the AC. Providence Pastor Nan Adam was invited to sit with the commission. The commission was appointed by presbytery at the request of Providence Session to assist with developing a plan for dissolution. During the initial meeting, the scope of work for the AC was identified. Rev. Nan Adams was asked to serve as an Ex-Officio member of the commission moving forward and accepted.

Due to the confirmed fact that Providence as a PCUSA Congregation functions under the "Southern Option" regarding property, the AC will serve in an advisory capacity only regarding possible sale of the church property. The AC will focus its attention on identifying legacy ministries Providence wishes to fund and / or support with any proceeds from the sale of its property. Providence Session has sought the advice and guidance of both The Presbyterian Foundation and its real estate wing, Foundry Commercial, and those resources will aid the AC in its work.

It is the intention of the AC to develop a plan for dissolution to be presented to Session and the congregation by the end of March.

# **Administrative Commission Report**

### **FPC-Anniston**

Presbytery Meeting, February, 2025

### DECEMBER, 2024

- December 1 The congregation of FPC-Anniston met immediately following worship. Moderator Frankie Tatum called the meeting to order. Session member Robert Downing explained that the dwindling congregation is financially unable to continue worshipping as the FPC-Anniston. Discussion included alternative places to worship and the inability to replace Session members whose terms are complete. The congregation voted unanimously that Sunday, December 22, would be their final day of worship. They voted to close the F&M, Anniston, bank account and disburse remaining funds.
- December 12 The Session met with CEO of the Community Foundation of NE Alabama to announce the suspension of worship on Dec. 22. Several items of business concerning finances and removal of church property were discussed.
- December 16 Work began in the Fellowship Hall to sort, purge, or save files and property belonging to the church. The Moderator and some congregation members will work until this is completed.
- December 22 Ernie Haynes, CLP, led the congregation in its final service. His sermon
  inspired them to move forward as faithful people of God. Thirty people were in
  attendance, including former members who had moved away. A check for Dr. James
  Woodward, longtime organist, was presented to him expressing gratitude for his many
  years of faithful service.
- January, 2025 The Moderator and church volunteers will continue to sort and purge church files to be delivered to the Presbytery Office for subsequent transfer to the PCUSA Historical Library. The Session will meet to consider closing the church's bank account, settling any and all debts, and disbursement of funds.
