Welcome from the Host Church

Terry Hamilton-Poore

Terry provided a welcome and historical overview of First Church. It was formed in 1872, and their building was constructed in 1888. They were the first of the downtown churches. She talked about the meaning of the stained-glass windows. Rick Shelton

wrote most of today's liturgy and was to be a part of the service. He unexpectedly passed away.

Order of Worship

Worship began with a Prelude. Darryl Love led the body in the Call to Worship, followed by the congregation singing "The Mighty God with Powers Speaks." He then led us in a Time of Confession, followed by the congregation singing "Spirit of the Living God."

The Assurance of Forgiveness was given by Terry Hamilton-Poore with a response sung of "Glory to God, Whose Goodness Shines on Me." Jothany James gave the Prayer for Illumination and the First Reading of Amos 7:7-15. A trio sang the Anthem "My Shepherd Will Supply My Need", followed by the Second Reading of Mark 6:14-29.

Terry Hamilton-Poore gave the Sermon "The Good News of Courage." Jothany James led us in the Affirmation of Faith and Carl Martin gave the Invitation to Generosity and Prayer of Dedication. "Turn Your Eyes Upon Jesus" was played during the offering, followed by the body singing the Doxology.

We were invited to Christ's Table by Elizabeth Goodrich. Terry Hamilton-Poore and Elizabeth Goodrich prayed a responsive Great Prayer of Thanksgiving, and the body joined her in the Lord's Prayer. The congregation shared the bread and cup.

Terry gave the prayer after communion, followed by the Hymn "God of Grace and God of Glory," and she gave the Charge and Benediction, followed by the Postlude.

Ministry Within Our Presbytery

Greetings from Dr. Yolanda Page, President of Stillman College She was introduced by Mark McCormick. She is the eighth president and starting her third year.

She highlighted the completion of the "ascend 2025" strategic plan, focusing on six key areas including academic programs, student success, cybersecurity, engagement, recognition, and "destination Stillman." Page discussed the college's partnership with the Presbyterian Church USA and emphasized their cradle-to-career approach, including the Jumpstart program and a new HBCU charter partnership with I Dream Big Academy. They have been hosting a jump-start program, which is a six-week school to help children get ready for school. They also enrolled 200 middle school children for a summer program. Google awarded them a \$1 million grant to assist them in continuing these programs.

She also mentioned ongoing cybersecurity efforts, faculty wellness programs, and the college's economic impact, and concluded by inviting support for the Winsborough Hall project and announced plans to celebrate Stillman's 150th anniversary.

The Search/Transition Team has worked diligently since the May presbytery meeting to find the best candidates for the next General Presbyter and the next Stated Clerk. We made the decision to pursue two people for two separate positions.

To understand fully the qualifications and skills necessary for both positions, and to include all people who care about the future of this presbytery, both clergy and lay, we sought input in several ways. We met with both Sue Westfall and Jay Wilkins, who informed us clearly on the current states of the offices. We provided a survey, available to all who wanted to respond, with questions designed to elicit the responder's observations and wishes concerning new hires. We met with the Executive Council, the Commission on Ministry, and the permanent and volunteer staff, thus engaging in relevant conversation not only about the current status but also the future of PSL and what they hope for in new leadership.

We are now in the process of preparing the job descriptions and Ministry Discernment Profile necessary to begin official searches for these positions and hope to have them ready for approval soon.

Stated Clerk's recommendations for edits to our Standing Rules: 3/3/2025 additions in bold italic: deletes strikethrough.

FYI -- I have been communicating with our Trustees who are realizing that they do not have an avenue to report to the Executive Council. I have two recommendations (1 & 2 below) for including the Presbytery Committees (as they are titled in the Standing Rules) in the regular work of the EC.

The third suggestion comes from confusion over wording in the Standing Rules regarding quorum for our meetings, and from shrinking numbers of churches. Pat Goodman did a lot of research comparing quorums from many Presbyteries! A reminder -- the process for changes in the Standing Rules is described in the Rules: SR-2.01.03 These Standing Rules may be amended as follows: A proposed amendment shall be presented in writing to the Executive Council, which in turn shall present the proposal to the next meeting of Presbytery with its recommendations. To become effective, an amendment must be approved by two-thirds of the votes cast at one meeting of Presbytery and adopted without further revision by two-thirds of the votes cast at the next meeting.

- 1) on page 12: SR-6.01.01.03 The Executive Council shall ordinarily meet monthly and on the call of the moderator of the Executive Council. *At each meeting, the Executive Council shall invite and receive reports from the Presbytery Committees: Trustees, Nominating and Representation, and Anti-Racism.*
- 2) on page 16: SR-6.01.03 Presbytery Committees

 A representative from each of the Presbytery Committees (Trustees,
 Nominating and Representation, Anti-Racism) shall be invited to report to the
 Executive Council at its meetings.
- 3) on page 6: SR-3.01.05 A quorum of a stated meeting of the Presbytery shall be 20 Ministers of Word and Sacrament and 20 ruling elders, representing at least 20 congregations. A quorum of a called meeting of the Presbytery shall be 15 Minister of Word and Sacrament and 15 ruling elders, representing at least 15 congregations. shall be no fewer than three ministers of the Word and Sacrament who are members of the Presbytery and three ruling elder commissioners from three different congregations. (Book of Order G-3.0304) This permits Administrative Commissions to function as the Presbytery.

Providence Administrative Commission Report

The Providence Presbyterian Church Administrative Commission has not met since our last report. Session continues to guide the process towards dissolution in keeping with the decision made by Presbytery at the May meeting. Here is an update on where that progress stands:

• The original sales contract was canceled by the potential buyer. Foundry Commercial, the real estate body in covenant with the Presbyterian Foundation, reached out to the second interested party and sale is anticipated to close in late August or early September. ARC of Montgomery, a private school, is purchasing the facility to use as a school. While there are numerous hurdles to clear, there is no indication that the sale will not reach closure. Arc is purchasing the building in "As-is" condition, including the majority of the furnishings. Remaining members of Providence have all chipped in to find new homes for church supplies Arc is not interested in and have used all proceeds from sale or donation to offset the costs of keeping the building open and utilities turned on.

- Session has met and approved Transfer of Letter of Membership requests for several former members. They will make one final effort to contact all remaining roll members to extend that opportunity.
- Session appointed a team of three to make recommendations for legacy funding
 of ministry with the proceeds of the sale. The Administrative Commission will
 hear from that team once the date for closing is clarified and will assist in that
 process.
- Once the sale is final and all legal matters settled, Session and the AC will set the date for dissolution. That action, previously approved at the May meeting of Presbytery, will become effective at that time.
- Rev. Nan Adams has accepted a call to serve First Presbyterian Church of Palestine, Illinois.

Appendix C-2 Enrichment Workshops at the August 21, 2025 Presbytery Meeting

Beverly Thorn, psychologist specializing in care for the caregiver (zoom/sanctuary)

Dementia is a brain disorder leading to eventual loss of personal autonomy and death. Understanding dementia helps caregivers cope more effectively. Further, fostering communication among loved ones allows for life values clarification and the ability to plan for advanced care preferences and options. Such discussions can provide great relief to family caregivers, helping ameliorate guilt and enabling healing grief. Church leaders can have a role in facilitating such discussions among congregations, thus lightening the burden of dementia and caregiving.

Beverly E. Thorn, Ph.D., is a clinical psychologist, certified end-of-life doula, and former dementia caregiver for her husband. She spent her academic career publishing and speaking on managing chronic illness. Her new self-help book, released in May 2025, is entitled *Before I Lose My Own Mind: Navigating Life as a Dementia Caregiver*, Girl Friday Books. Rev. Cort Gatliff on Proverbs and Wisdom Literature

Proverbs Seminar

How does one become wise? We live in an age overflowing with information and knowledge, yet true wisdom feels increasingly scarce. Thankfully, God has given us a source of ancient wisdom that has stood the test of time and applies to our modern lives: the book of Proverbs. In this seminar, we'll explore how the often-neglected book of Proverbs shapes our character, guides our relationships, anchors us in the fear of the Lord, and ultimately points us to Jesus, who is wisdom incarnate.

Rev. Cort Gatliff is the Senior Pastor at South Highland Presbyterian Church. He is a graduate of the University of Tennessee and Beeson Divinity School. He lives with his wife, Rev. Abby Gatliff, and their three daughters in Homewood.

Jay Wilkins on changes to our new Book of Order 2025-2027, and implications for churches What Have We Done to the New 2025-2027 Book of Order?

Our Book of Order, Part II of The Constitution of the Presbyterian Church (U.S.A.), is a living document, being reformed by proposals from presbyteries, by approval of the General Assembly, and then by affirmation of a majority of presbyteries. However significant, or insignificant, the changes are perceived, faithful elders and ministers are to stay informed of the changes and how they may connect to the life of our congregations and the presbytery.

This workshop will be led by Jay Wilkins, the Stated Clerk of Sheppards & Lapsley Presbytery. We will review the changes that need attention for our life together, and focus on two changes that have provoked much discussion. We plan to have copies of the new BOO available, if you pre-register for this workshop.

Appendix C-3

Job Description for Stated Clerk of the Presbytery of Sheppards and Lapsley (approved by Search Team 8/11/2025)

The Presbytery shall elect a Stated Clerk to serve a term of three years and shall be eligible for re-election for a maximum of three terms.

The Stated Clerk position is expected to require ten hours a week, most weeks, and forty hours per month most months, with flexibility to account for meetings, conferences, and travel. Much of the work can be remote, but the Stated Clerk will need to be present at some meetings and events and should have at least an occasional presence in the presbytery office.

Compensation for the position is \$12,000. Professional and travel expenses are reimbursed at the IRS approved rate. (This is the recommendation of the Search Team)

The Stated clerk shall serve according to the provisions of the Book of Order (G.-3.0104, G-3.0305) and guided by the more specific duties outlined in the Stated Clerk's Handbook provided by the Office of the General Assembly.

The Stated Clerk shall serve as parliamentarian and shall be available to assist individuals and groups with advice regarding presentation of matters to the governing body.

The Stated Clerk shall see that session records are reviewed in accordance with G-3.0107.

When the Stated Clerk is absent or unable to function, the Executive Council shall appoint a temporary Stated Clerk until a permanent Stated Clerk is elected.

The Stated Clerk will:

- Attend G. A. Stated Clerk Training
- Attend Stated Clerk Meetings and Polity Conference, and in as far as possible Synod Meetings and General Assembly.
- Fulfill the Book of Order requirements in G-3.0106: "All councils shall adopt and implement the following policies: a sexual misconduct policy, and an antiracism policy. Each council's policy shall include requirements for boundary training which includes the topic of sexual misconduct, a harassment policy, a child and youth protection policy, and an antiracism policy. Each council's policy shall include requirements for boundary training which includes the topic of sexual misconduct, and child sexual abuse prevention training for its members at least every thirty-six months."
- Fulfill the responsibilities regarding the Child and Youth Protection policy.

- o Secure background checks on all Presbytery staff, pastors, and educators as indicated in the Child and Youth protection policy.
- Secure background checks on all chaperones and other leaders to Presbytery events involving children and youth as indicated in the Child and Youth Protection Policy.
- Keep records of those who have participated in the COM approved boundary training and in the approved antiracism events every three years.
- With the Assistant to the Stated Clerk, prepare for Council approval the Per Capita Budget to be presented to Presbytery.
- With the Assistant to the Stated Clerk, once the Per Capita Budget has been approved by Presbytery, prepare letters to be mailed to Session Clerks re Per Capita, church staff forms, remittance forms for following year, etc.
- With the Assistant to the Stated Clerk, at the end of each quarter, follow up with churches that have not paid or made arrangements for payment of per capita.
- Provide training for Clerks of Sessions as well as opportunities for Clerks of Sessions to read minutes of other churches. Thia may be done at Saturday morning training/reading sessions as needed. Churches may also drop off or mail their minutes to Presbytery for Stated Clerk to review and sign.
- Serve as a staff resource person to all Administrative Commissions, with voice but no vote. Provide resources and training for each Commission prior to their first meeting with the parties involved.
- Serve as an Advisory Member to the Executive Council, Commissions on Ministry and Preparation for Ministry, and the Response/Review/Commission process with voice but not vote.
- Respond to day-to-day Polity questions.
- Handle within the Judicial Process matters regarding remedial and disciplinary cases and investigative committees as outlined in the Book of Order, Church Discipline section. Association of Stated Clerks has a Handbook online for this process.
- Ensure preservation of Presbytery files.
- Assist Presbytery Trustees as needed.
- Keep abreast of what is going on within our denomination regarding property, court decisions, and other issues affecting our churches. This information is found online through the Office of the General Assembly, the Association of Stated Clerks and by contacts with other Stated Clerks across the denomination.

For each Presbytery meeting, do the following:

- With information from the Assistant to the Stated Clerk and the General Presbyter, prepare a proposed docket for quarterly Presbytery meetings and submit to Executive Council for approval.
- Prepare Stated Clerk report for each Presbytery meeting.
- With the COM, provide for memorials for deceased Ministers of Word and Sacrament.
- With the Assistant to the Stated Clerk prepare and distribute to all appropriate participants a packet containing a proposed docket and all known business coming before Presbytery.
- Give notice of the meeting to participants at least ten (10) days in advance.
- Meet with the Presbytery Moderator prior to the meeting to review parliamentary and polity concerns that could arise with the docket.
- With the Assistant to the Stated Clerk, prior to the opening of the meeting, enroll Presbytery's members and certify to the Moderator the presence of a quorum.
- With the Recording Clerk, see that accurate minutes are kept. Minutes are to be reviewed by the Stated Clerk and the moderators of the Executive Council and Presbytery and then made available to the Presbytery.
- Assure the numerical parity of teaching elders and ruling elders to be enrolled as voting members at any stated or called Presbytery meeting, following the method to be found in the Standing Rules of Presbytery.
- With the Assistant to the Stated Clerk and Recording Clerk, report to Presbytery those teaching and ruling elders asking for excuse from meetings.
- Receive the reports of Presbytery Administrative Commissions and forward the reports and any proposals for action to Presbytery for discussion and vote.
- Act for the moderator in calling special meetings of Presbytery when the moderator is unable to do so. Act as Recording Clerk for those meetings when neither the Recording Clerk nor a substitute is available.

Communications with the Synod and General Assembly.

- With the Recording Clerk and Assistant to the Stated Clerk, annually submit minutes to the Synod for review.
- Together with the Recording Clerk and the Assistant to the Stated Clerk, prepare the previous year's Presbytery minutes for transmittal to the designated Synod representative within the requested time frame and transmit them.

- Annually review the minutes of one other presbytery of our Synod as designated.
- With the Assistant to the Stated Clerk, see that Annual Statistical Reports are distributed and prepared by our churches and submitted to Synod and General Assembly with necessary information to Presbytery.
- See that General Assembly Commissioners are trained.
- Report to the Office of General Assembly (OGA) all changes in status of Teaching Elders (receptions and dismissals, changes in status – such as Honorably Retired and Members-at-Large) and all Commissions of Ruling Elders.
- Report to OGA all changes in status of Presbytery churches (new church development, closings, dismissal to other denominations and moves/relocations).
- Submit to OGA other reports as required.

Physical Requirements: The physical requirements described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.

While performing the duties of this job, the employee is regularly requested to sit for prolonged periods of time. Close vision and manual dexterity are required to access data utilizing a personal computer and other office equipment. Talking and hearing are also necessary when utilizing the phone for customer service and for presentations during meetings. Lifting up to fifteen pounds may be necessary to move file boxes and supplies.



Report of the General Presbyter of the Presbytery of Sheppards and Lapsley August 2025

What does faithful witness and ministry in the Presbytery of Sheppards and Lapsley look like in these days? I submit that the docket of this meeting itself gives us a powerful glimpse of faithful witness to the gospel of Jesus Christ and his mission. Please notice with me:

- First Presbyterian Church, our host for this meeting, is an historical urban congregation which, despite opportunities to move to the suburbs and abandon the inner city, instead chose to stay and minister in an urban context. Partners in the founding of the Fresh Air Farm and more recently in the First Light residential housing for women and children in which many of our Birmingham area churches participate. In the 1960's they took a bold stand for racial equality. While it cost the pastor his job, the church then and now witnessed to the inherent worth of all God's children.
- Worship together. As the life of a congregation centers on the act of worship, so
 does the life of the presbytery. Here we gather to give our praise, our honesty,
 our resources to God and with each other hear in word, music, and sacrament,
 the ancient promises of God and God's call to join him on the sacred mission of
 saving the world. Far from "making the meetings longer" it grounds the meeting
 at the center of our life and witness.
- We enjoy an historic relationship with Stillman College though the PCUSA.
 Stillman College was started as a theological school for training African American men toward the end of the 1800's. In the 20th century it became first an accredited junior college (1937) and then an accredited four-year college. It remains a vibrant HBCU providing life-changing opportunities for young people of all races and circumstances. Stillman will be the host of the Congo Mission Network this fall!
- We're taking some time at this meeting for enrichment. John Calvin, our Presbyterian ancestor, imagined presbyteries as groups of pastoral and other leaders from various congregations gathering to build one another up – in Bible study, in prayer, in the common good and we will do that here this day. No one is alone in this ministry and the presbytery helps us hone our skills! In addition later this fall the presbytery is offering a retreat to deepen the ministry of small church pastors and leaders (which is the vast majority of our congregations) with the highly regarded Phil Blackburn. (See flyer included) I hope you will come!
- And of course we enjoy table fellowship at the communion table and also in the fellowship hall connecting with our colleagues, renewing friendships, making new ones. Enacting community.

- We welcome Kenan Rodgers from the Presbyterian Board of Pensions.
 Collectively our churches practice justice by insuring health care and a retirement plan for our pastors. Recently, the Board of Pensions has been able to expand their services to include more part-time positions and Commissioned Pastors and we celebrate the community nature of this valuable resource.
- We will hear from our mission partners. The Presbytery of Sheppards and
 Lapsley sends volunteers and generous gifts to the ministry of The Presbyterian
 Home for Children and many of our members serve on its board. Same with
 Living River. In addition to the generous gifts many of our congregations and
 individuals make to Living River regularly, the presbytery subsidizes it's work by
 nearly \$3000.00 monthly and send our children while Living River helps us raise
 up leaders for the church and world tomorrow.
- We've had a lot of tornadoes this spring particularly in Selma and the Black
 Belt. Thanks to the generosity of our churches and in partnership with the
 Presbyterian Disaster Program we have collectively sent thousands of dollars for
 needed repair and restoration. (See more in Ralls's report)
- Today we will also celebrate the ministry of the Commissioned Pastor program.
 This program of overseeing the preparation of elders for pastoral ministry provides excellent pastors for many of our churches. Today we have the joy of receiving John Schuler into the presbytery as a Commissioned Pastor and commissioning both John and Sharon as Co-directors of the CP Program in conjunction with the COM.
- Meanwhile, as I write this so very many congregations in our presbytery are stuffing back-packs with essential school supplies. The first Sunday of August, many will bless those back-packs and the young people who will use them as they take on this new school year in God's good care.

This presbytery meeting is a snap-shot of the presbytery's life together. As with any snap-shot, it does not show the whole panoply of wat the presbytery is about but it is a vivid glimpse of what is a rich and enriching life. The presbytery depends completely on the generous giving of our member churches and I thank you for valuing this shared life with your generous contributions!

2026 Rates and Employer Agreements

Due to challenges in the healthcare industry that continue to drive up costs, the Board of Directors approved medical dues increases in June for 2026 for the Congregational Pastors Package and Transitional Pastor's Participation. Dues for the income protection benefits in the packages, including death and disability and pension, will remain at 10% of effective salary in 2026. Rates for Benefits Plan offerings provided outside of packages will be available to employers in Benefits Connect on Aug. 28, when Employer Agreement season opens. The Decision Guide for Minister Benefits tool, which helps with cost calculation and eligibility, will also be updated. See details in the <u>Summer Board Bulletin</u>.

Mental Health

Spring Health, the new provider for the Employee Assistance Plan (EAP), offers eligible plan members a variety of mental well-being and EAP services, including mental health care navigation, six clinical therapy sessions at no cost to them, and unlimited virtual coaching sessions with certified coaches at no cost. Every Spring Health provider is in-network with Highmark BCBS, so if the member is also enrolled in medical benefits, consultations with a Spring Health mental health care provider can continue with lower copays and deductibles.

Should a minister or staff member need to take leave to focus on mental health, they can consider applying for <u>Temporary Disability</u> benefits. Temporary Disability may be offered by itself or as part of the <u>Covenant Package</u>, <u>Congregational Pastors Package</u> and the <u>Transitional Pastor's Participation Package</u>.

The Holy Spirit acts to guide us to focus on God's will and to do God's work here on earth. Through the gift of Jesus Christ, those who truly believe and live that belief through their lives will receive the gift of eternal life.

We are a broken people in a broken world. The Gospel calls on us to reach out to accomplish the love, healing, peace, and justice of Jesus Christ here on earth.

God created humanity in God's own image. God sought out a close relationship with humanity and we continually turn away from God. God seeks us out and wants us to live with each other and to live for God, so that God might enjoy us and that we might worship and enjoy God.

The following summer (2005) I spent the summer serving First Presbyterian Church of Leadville, CO. Here again, I spent the summer in deep thought and prayer listening for God's call. Once again, I heard God calling me toward small church ministry.

After I graduated, the small church was still where God was calling me to serve. For eight months (2006-07) I served a small church in Bremen, GA. I was their pastor in every sense. I felt God provided this church so I could have more experience in this form of ministry.

After my wife, Sharon, accepted her call to First Presbyterian Church in Monticello, FL, I continued to try to find ways to continue to be involved in ministry. I have joined and am active in the life of that church. I have become involved in the Presbytery by serving as a commissioner, and as a member of the Budget, Finance and Stewardship committee. 2. The Dallas County Long Term Recovery Group was formed in the winter of 2023 after the tornado that devastated parts of Dallas County and Selma. The LTRG was comprised of local community leaders, clergy, business people and funders from around the state. Cornerstone Presbyterian Church of Selma, the Episcopal Church, the Lutheran Church, Grace Tabernacle of Selma, the Edmundites (a Catholic order), Mennonites, the United Methodist Church and our Presbytery all worked together to raise funds and repair/rebuild housing in Selma. UMCOR (United Methodist Committee on Recovery) provided the case management for 230 open client cases, performing 95 repairs/rebuilds of homes, and distributing almost \$2.5 million dollars. Our Presbytery contributed \$44,439.97 to replace appliances and furniture, repair roofs and help build 2 houses. This helped 10 families.

The work of the Dallas LTRG is now completed. We had a Celebration Supper in Selma July 8, where the families, the funders, the UMCOR team all met and heard each other's stories.

Thank you Presbytery churches for all your generous help. It is time to give thanks to God.

There is much poverty in the Black Belt and so we will continue to be active in service there. Also, please do not forget about those who are suffering in western North Carolina and in Texas. The Presbyterian Church focuses on long term recovery in the aftermath of disasters.

Again, thank you, Presbytery of Sheppards and Lapsley. And thanks be to God.

3. The Pentecost Can-paign for 2025 ended on August 11, 2025. Churches in our Presbytery collect food and money to donate to hunger organizations of their choice. The Can-paign is a way to keep in our hearts the need to combat hunger. We should have the total collection numbers from the churches by our in-person Presbytery meeting.



"Starting my first summer as a counselor at Living River (LR), I didn't know what to expect. It was my first time ever being at a summer camp, my first camp job, and to be honest, I've never been a big fan of the outdoors, which made the experience feel even more scary at first. But despite all of that, LR quickly became more than just a job— it became a space where I grew in ways I never expected. I saw campers who were also new, just like me—unsure, nervous, and figuring things out—and that helped me realize I



wasn't alone. I learned how to lead with patience, how to connect with people from all different backgrounds, and how to show up as my full self even when I felt out of place. Executive Director's Corner- an interview with WBRC, "Summer camps reviewing safety plans after Texas flooding disaster," 07/24/2025

"As the summer camping season winds down, we're talking with a local camp about their safety plans after the flooding in Texas. The flooding disaster that killed dozens at Camp Mystic in Texas was a gut punch for Jenny Thagard, the executive director of Living River: A Retreat on the Cahaba. 'I think people all over the country that have the safety and lives of children in your hands, it was just devastating,' Thagard said.

Last week, Thagard met with emergency management officials in Shelby and Bibb County to go over their safety plans. Living River is 10 years old. Its cabins were built in 2015. The camp sits on 440 acres of forest and is surrounded by four and a half miles of the Cahaba River. It's built up from the river. "While we are surrounded by the river, our elevations are high enough to where our buildings cannot flood. So, we're 53 feet above the lowest elevation line and then there's another drop down to the riverbed from there," Thagard said. Since Alabama is susceptible to all kinds of weather, Thagard says communication is key. That was a big thing they discussed with emergency officials. "We've talked about how we get alerts and the importance of getting alerts and having multiple ways of getting alerts. We have an evacuation plan. We've never had to use it. We kind of fine tuned that. Where would we go if so we did a lot of what if's. We also have long range radios and short-range radios that we can use to communicate with each other just in case other communication systems go down," Thagard said.

Thagard is a longtime educator and former principal. She says safety is always top of mind. She has this message to parents who may be wary of sending their kids to summer camps. "Their safety and security is our top priority. It always has been. We've had plans in place. This has brought them more to the top of our mind and it's also made us more aware of maybe publicize those to make parents feel better," Thagard said. Thagard tells us every year after summer camp, they meet with emergency officials to talk safety, but the devastating situation in Texas elevated that conversation even more this year.

Dear Friends in Christ:

The Presbyterian Home for Children is profoundly thankful to the Presbytery of Sheppards and Lapsley for your steadfast prayers, encouragement, and unwavering support of our shared mission to care for at-risk children and families in need. We are truly grateful for the vital role you play in this mission.

The Home has seen a lot of success recently with the Secure Dwellings as several moms graduated from the program and rediscovered their independence. One great example is Rebecca Beal, who came to the Home in June 2024 after leaving an abusive boyfriend and living in a relative's garage. She and her two boys settled into Ramsey Cottage and our team went to work helping her find a good job and placing the boys at our private school, Ascension Leadership Academy and Cheaha Regional Head Start. We are so very proud of this entire family and featured them in our Summer Beginnings Newsletter. As Rebecca prepared to leave in May for her own apartment, she said, "God made this possible." At the May PHFC Board meeting, Rebecca gave her testimony in person and shared lunch with our Board.

Secure Dwellings alumnus Bizzy is doing great more than seven years after leaving the Home when she was homeless with her two young boys. Today, those boys have grown up! Her oldest, Logan, just got his pilot's license and is in the US Air Force ROTC at Mississippi State while attending East Mississippi Community College. His day starts at 4 a.m. for PT followed by a day of classes. Her youngest, Caleb, is active in theater at high school and plans to follow his brother's path to the Air Force in cybersecurity. He landed a job downtown at one of the finest dining facilities in Wetumpka. Bizzy says PHFC gave her boys a place to call home and contributed to them growing into compassionate, respectful young men. She is a member of First Wetumpka, and we are so grateful for the partnership that we have with Rev. Jonathan Yarboro and this congregation. Bizzy summed it up well when she said, "These children have healed every hurt my younger self experienced. All I know is love and gratitude."

The Presbyterian Home for Children had an impactful mission outreach school year with children and youth in rural Wilcox County. In a partnership with local nonprofit M.I.N.D. Mentoring in New Dimensions, the Home completed a yearlong weekend backpack program that sent food home with 40 children in the most need at the school, and we gave out 500 new Nike tennis shoes to teens at Wilcox's middle and high schools in a partnership with Tuscaloosa nonprofit High Socks for Hope to strengthen our relationships with these students and families. This spring, the Home started stocking a Caring Closet at F.S. Ervin that provides immediate-needs items for the 200 children, because kids learn best when they feel their best. The Home plans to offer a Caring Closet in Wilcox County's two other elementary schools during the 2025-26 school year as part of our mission outreach.

The Home made a strategic move to renovate and repurpose Robinson Cottage on campus to serve as the Family Unity Center. Robinson will serve as a home for mothers who lost custody of their children to the Alabama Department of Human Services due to unsuitable living conditions. By living at Robinson, they have a safe, stable place to live and trained PHFC staff provide case

management services to help the moms regain custody of their children and reunify the family. Moms learn parenting and basic living skills, money management, decision making, job readiness, and more. We even have an apartment that each can reserve on a given weekend for unsupervised visitation with their children. And, once the children are returned to their mother, they can receive continuous case management service and support for up to two years in the Secure Dwellings program or move to secure and safe housing in the community.

The Home just received word that the third year of the three-year grant for our Caminos® Program with the Office of Refugee Resettlement will be funded in 2026! Thirty-four children from ages four to 18 have been served through this expansion of crucial services to children in Alabama, adjoining states and even beyond. We are very grateful for our Caminos® Team helping to protect these children and families.

The Presbyterian Home for Children leadership team has spent the last year prepping to earn renewal of the prestigious Educational Assessment Guidelines Leading toward Excellence, or EAGLE Accreditation. The Home has been accredited since 2017 by EAGLE, which is the highest standard for a faith-based organization serving children, youth and families to accomplish. An EAGLE National Accreditation Review Team will visit in mid-September to see how we practice what we say we do in the paperwork. They will review our programs for children and families, our facilities and how the Home operates, and how the Home manages finances and fundraising. The accreditation process is a great way to regularly check our functional systems to ensure we are using the best practices out there to fulfill our mission and enhance our impact for those who need us most.

In June, the Presbyterian Home for Children dedicated another new tiny cottage duplex in our Union Village development, our permanent supportive housing community with full wrap-around program support from the Alabama Institute for Deaf and Blind for adults who are Deaf, Blind, DeafBlind and multi-disabled. The two new cottages were dedicated to Second Presbyterian Church in Homewood in recognition of the church's \$300,000 donation for construction of the duplex and other campus improvements. The cottages are appropriately named Hope and Faith. We are so grateful for this gift from within the Presbytery of Sheppards and Lapsley.

The Home has room to help more moms in need! SECURE DWELLINGS GRADUATE CELEBRATES NEW LIFE



Rebecca Beal and her two young boys were living in a family member's garage when they found out about Secure Dwellings at the Presbyterian Home for Children's campus in June 2024.

Rebecca had been kicked out of her abusive boyfriend's house – again. She decided she was done, and she was never going back.

Her car packed with all her belongings, Rebecca started looking into shelters when she was referred to the Home's Secure Dwellings program. With the Home, she can stay for up to two years and be given a chance to breathe and dream of what she wants for her family's future.

"I was looking for a way out," she said. "And we found the Home."

When Vice President of Transitional Housing Sharon Moore and her team gave Rebecca the keys to her own apartment in Ramsey Cottage, one of her first questions was where to find the washer/dryer and whether it took coins. She was shocked to learn the apartment came with its own set.

"God made this possible," Rebecca said. "God said, 'You go where the boys are happy, where there's not a mad man in the house."

As part of being in Secure Dwellings, her oldest son, Braylon, 7, was enrolled into the Home's private school, Ascension Leadership Academy. Through a partnership with Cheaha Regional Head Start, her youngest, Jaxton, 5, was placed in a Pre-K program.

Rebecca said Braylon's grades weren't good before he came to Ascension. After a year of being taught by master teachers who are trained to help children coming from challenging family situations, Braylon finished in May with all As and Bs.

"It was rough before, but now he's doing great," she said.

The Secure Dwellings team helped Rebecca get a good job with a Talladega retail store, and she started saving her money for a deposit on an apartment as she finds her way toward independence.

After a year in Secure Dwellings, Rebecca saved enough to secure a new apartment, and in mid-May, she and the boys moved in. While they graduated from the Secure Dwellings program, Rebecca's family is still connected to the Home. Both boys are set to attend Ascension Leadership Academy next year to continue their strong education progress.

Congratulations to Moneè Brown, daughter of Secure Dwellings alumnus Shandra Thomas, who recently graduated from The University of Alabama with her bachelor's degree in criminal justice using the Home's Archibald Ritter Green Scholarship.

Four of Thomas' seven children graduated from Ascension Leadership Academy and continue to blossom in their post-secondary paths—a powerful testament to the impact of education and a loving foundation. Daniel has a wonderful job and career ahead at the Mercedes plant near Tuscaloosa, while both David and Phaethon graduated from Parris Island and are serving as U.S. Marines.



WILCOX COUNTY MISSION UPDATE

HOME GIVES OUT 500 NIKE TENNIS SHOES IN WILCOX COUNTY AS MISSION OUTREACH PROGRAMS EXPAND

The Presbyterian Home for Children finished an impactful mission outreach school year with children and youth in rural Wilcox County with an end-of-the-school-year party and a giveaway of more than 500 free Nike tennis shoes as the Home strengthens its relationship alongside local nonprofit M.I.N.D. Mentoring in New Dimensions in these communities.

This spring, the Home also started stocking a Caring Closet at F.S. Ervin Elementary School in Pine Hill, Alabama. The Caring Closet provides immediate-needs items for the 200 children, because kids learn best when they feel their best. The Home plans to offer a Caring Closet in Wilcox County's two other elementary schools during the 2025-26 school year.

The first item delivered for the Closet at Ervin Elementary was a washing machine that allows staff to clean children's uniforms and other items like nap mats that may not get cleaned when taken home to family.

Later this summer, the Closet will get packed with supplies that students need but are not ordinarily offered by the school, such as new uniform pants and shirts, hoodies, undershirts and underwear, socks, deodorant, toothbrushes, snacks, and bottled water.

"Supplying the children with basic-needs items helps them learn better in their school environment," Mission Outreach Director Cindy Fisher said. "It levels the playing field for those at a disadvantage at home and increases their academic performance and quality of life. Not having adequate and appropriate clothing can impact a variety of social and economic aspects of a child's life, including peer acceptance and education opportunities."

In May, the Home completed a yearlong weekend backpack program that sent food home with 40 children in the most need at F.S. Ervin Elementary School. The Home celebrated the end of the school year with meals for 185 children in partnership with M.I.N.D.
















For the end-of-the-school-year celebration this year, the children got a full meal from the Home at their special May Day festivities on May 9. The lunch included chicken, baked beans, and coleslaw and was prepared by Arlington Presbyterian Church, which is located in Wilcox County.

The Home staff returned to Wilcox County on May 14 with two vans full of 530 Nike tennis shoes that were donated by nonprofit High Socks for Hope in Tuscaloosa. The sneakers were Nike's Kyrie Irving brand, named for a well-known professional basketball player.

The shoes were given to seventh and eighth graders at Camden School for Arts and Technology and to ninth through 12th graders at Wilcox Central High School.

The Nike shoes were also given out to students at Ascension Leadership Academy and families living on our Talladega campus.

Thanks be to God for all who serve as the clerk of session in our congregations! Clerks are the record keepers, telling the story of the congregation and its participation in Christ's mission in the world. Clerks are the process managers who keep the leadership organized and focused on the sense of calling God has placed before you.


