Report from Transition/Search Team November 20, 2025, Presbytery Meeting

The Transition/Search Team has come to the point in the search process where we have been meeting often to fulfill our mission to find and present for approval to Presbytery a Stated Clerk and a General Presbyter.

As of this writing (October 31), we have received applications and interviewed candidates for the Stated Clerk position. At our next meeting, the Team will continue to discern the best way forward for both the candidates and the Presbytery. I will update Presbytery when I make a report at the November meeting.

We have also received applications for the General Presbyter position, and the stated deadline has passed, October 31). We will review the applications, check references, and hopefully begin to interview candidates as soon as possible. Again, I will update this report at the Presbytery meeting.

Report of the General Presbyter Presbytery of Sheppards and Lapsley November 2025

To all the saints in Christ Jesus who are in the Presbytery of Sheppards and Lapsley: Grace to you and peace from God our Abba and the Lord Jesus Christ. I thank my God every time I remember you, ⁴constantly praying with joy in every one of my prayers for all of you, ⁵because of your sharing in the gospel from the first day until now. ⁶I am confident of this, that the one who began a good work among you will bring it to completion at the day of Jesus Christ. Philippians 1:3

This is the last presbytery report I will write in my capacity as General Presbyter. Oh, I will be around for several more months as your General Presbyter but since this is the last time I will be addressing the whole presbytery in this way, I wanted most of all to express my joy, gratitude, and delight in working with you these past six years. If you don't have occasion to experience other presbyteries, you might not know how truly remarkable you are. Let me count the ways:

- 1. Your commitment to following and serving Christ and relying on the Spirit for discernment and decision-making. In this presbytery, prayer at the beginning and close of meetings (and frequently during the meetings) is not a perfunctory act but rather the sincere invocation of the Spirit's guiding and leading as well as thanksgiving for all God has done and is doing. Your life together is fueled by deep faith in Christ and his purposes.
- 2. Your camaraderie. There's a hymn which notes, "There's a sweet, sweet spirit in this place." There is a sweet spirit in this presbytery. You have developed warm, deep, respectful, and trusting relationships. You trust one another to act in good faith even when you disagree. This is a remarkable quality and enables you to act with integrity and effectiveness.
- 3. Your adaptability. Shortly after I began work here, the pandemic shut down the world. You formed a technology team to adapt to the changed landscape. Joe Genau had already been experimenting with a little platform called Zoom and he shared his knowledge freely. Relatively quickly, our committees and commissions were able to resume their work online. Those who were otherwise not tech-savvy did the work of familiarizing themselves with this new technology in order to participate in the presbytery's worship and work. You embraced this new moment so fully that even our presbytery meetings remain hybrid facilitating greater participation. This quality of adaptability makes you more nimble to move through changing times whatever the changes.

- 4. Your commitment to anti-racism and the Matthew 25 vision. At least once a month I get called by colleagues around the country asking about our anti-racism policy as they seek to implement similar commitments in their own presbyteries. You are a role-model and a teacher even as we all continue to learn. Here in the center of Alabama where the Civil Rights movement changed our country, you declare your continued advocacy for God's beloved community. Even your name gives witness to this commitment.
- 5. Your sense of humor. This is a presbytery that takes God seriously and itself lightly. This enables you to be gracious with one another, forgiving when things go awry, patient with complex processes, and makes your work together not just effective but enjoyable as well. Joy is a regular feature of our life together.

I commend you, Presbytery of Sheppards and Lapsley. It is a privilege and joy to work with you, know you, and serve Christ among you. And I know that that One who began a good work in you will bring it to completion at the day of Jesus Christ.

Mission Report to Presbytery, November 20, 2025

- 1. This Presbytery hosted the annual Congo Mission Network Conference at Brown Memorial Presbyterian Church in Tuscaloosa, October 23-25. The Conference was in-person and on Zoom. The Conference was on Zoom in the Congo, taking account of the 6 hour time difference. Speakers from DR Congo shared their information and wisdom with us. The theme of the Conference was on Ethical Leadership. There was an emphasis on the relationship between the Congolese Presbyterians and the American Presbyterians. The stories of William Sheppard, Lucy Gantt Sheppard, Samuel Lapsley and Maria Fearing were explored. The Conference ended with a trip to Sumter County to visit Maria Fearing's gravesite.

 Forty people attended the Conference in-person, with 100 registered attendees. We are very grateful to Brown Memorial Presbyterian Church for their work that produced a successful, well organized Conference.
- 2. First Presbyterian Church of Wetumpka contributed \$4,800 to help a victim of a tornado in Plantersville to receive a mobile home. This replaced a destroyed shed the client had been occupying.
- 3. This Presbytery is responding to the SNAP shutdown. Funds from the Pine Hill/Wilcox County Fund will be sent to Wilcox County to help local food pantries provide food. Other churches in the Presbytery are stepping up their hunger ministries to help in this crisis. We need to communicate with each other on the measures our churches are taking and to share ideas on how to help provide food for the hungry.

Presbytery of Sheppards and Lapsley Finance Committee Report November 20, 2025

The finance committee with the support of the Executive Council recommends approval of the proposed budget.

Notes:

- At the recommendation of the Personnel committee, we budgeted an 8% raise for Tammy.
- We budgeted for Sue to continue to serve as General Presbyter in January with the new GP to start in February.
- For the new GP we budgeted for the maximum of the posted range for the call.

There is an updated brochure included in the packet. We encourage you to share this with your sessions. We hope it will be a helpful tool for sharing about the ways we partner together to serve Christ in central Alabama.

The two largest funding streams to support our shared life as a presbytery are Per Capita and Mission Giving. Many people understand what per capita is. The proposal for 2026 is for each congregation to pay \$31.84 per capita for each member of their congregation. You will see on the back page how those dollars are split. Those funds go toward the Per Capita expenses of stated clerk, moderator, office manager/bookkeeper, commission budgets, and the general assembly and synod shares of the total per capita.

Our overall Presbytery budget for 2026 is about \$450,000. and per capita is only about \$200,000 of that or only about 45% of the total budget. About 7% of our budgeted revenue comes from lease revenue and other income. So almost half of our budget as a presbytery is funded by Mission Giving. Our mission as a presbytery is to "partner with and equip present and emerging PCUSA faith communities in central Alabama to serve Christ and our neighbors." The funds your congregations give to the Mission Giving of the Presbytery above per capita are necessary to fund that work. Thank you for the many ways you support this shared call.

Working with the COM we have asked every congregation for volunteers for Presbytery committee work and which committee/commissions are of interest to them. Several people sent responses but we always wish that more would respond. We did our best to nominate these volunteers to committees of their interest. We started the nominating process by contacting the committee chairs/moderators asking "of the members rotating off this year, who would you want back on your committee, who showed up for meetings, who served with enthusiasm and looking forward is there anyone you would like to see on your committee?". We took this information into consideration as we did our work. We delegated tasks, reported back regularly via email and at meetings and kept copious notes. Still, we did not avoid the end-of-year rush.

- 7. List future goals and objectives (for next 3 years):

 - B. Continue open communication with Moderators for suggestions on what gifts and abilities they need in committee members.

- 8. What is your Presbytery doing to recruit leaders who have special physical needs? We haven't specifically discussed special physical needs, but have talked at length about the needs around a language barrier. The Presbytery is trying hard to increase our ability to communicate with the Korean members of Presbytery. Communication has been a deterrent in participation on the part of Korean churches. We are hopeful that technology will allow translation from English to Korean at Presbytery meeting and eventually in committee meetings. We have had participation currently and for the next year by a couple of pastors, but no members, thus far.
- 9. How do you evaluate your own committee's effectiveness? (Tell us how you do your evaluation and what you've discovered about your work.)

 The Committee on Nominating and Representation has had a mix of non-participating and participating members, with the members that did show up working very hard. We stayed closely in touch, via email, between physical meetings, having divided up tasks for filling committees/commissions.

 We still have some members serving on multiple committees while other churches are not represented on committees. (The "80-20 rule" continues to be at work!) It is important to

represented on committees. (The "80-20 rule" continues to be at work!) It is important to encourage all churches to participate in Presbytery committee work so that their voice can be heard. The silent church as well as individuals will be a goal for inclusion next year.

10. How often does your committee report to Presbytery? What is the basic style of presentation—oral, written, visual, all of these?

How often? Every quarterly stated meeting of Presbytery. Throughout the year, vacancies in unexpired terms arise for all the various reasons.

Style? Written reports are always included in the advance information sent to commissioners, with brief oral reports (particularly encouraging more participation) presented at each stated meeting. The names of the entire committee are included at the end of every report for ease in contacting.

11. What are your most significant achievements in accomplishing "fair representation" in your presbytery since your last report to the Synod?

This year's committee has inherited some well-balance participation in committee assignments from our predecessor members - especially in regards to gender and racial/ethnic balance. We will continue these efforts along with awareness towards geographical diversity and small church representation. We often seek - and have had success - securing successors from the same churches, with the same representation identifiers. When this hasn't happened, we examine existing committee makeup and work to nominate people that will maintain or improve representation.

Trustees' Report Presbytery of Sheppards and Lapsley November 20, 2025, Assembly

For Information:

- As authorized by the Presbytery Assembly in a called meeting held on October 3, 2025, the closing of the sale of the property formerly owned by Five Mile Presbyterian Church occurred on October 9, 2025. The net proceeds paid to the Presbytery were \$457,938.15.
- The gift of the property formerly owned by **Fairfield Highlands Presbyterian Church**, authorized by the Presbytery Assembly in a called meeting held on October 3, 2025, has been accepted in writing by Faith Church at Midfield, effective January 1, 2026.
- The sale of the property formerly owned by Center Point Presbyterian Church, authorized by the Presbytery Assembly in a meeting held on November 21, 2024, has not been closed due to the purchaser's inability to obtain funding. The Presbytery's real estate agent is marketing the property to other potential buyers, while at the same time the original purchaser is continues attempting to obtain funding.
- The property formerly owned by **Good Shepherd Presbyterian Church (Anniston)** was subject to a sales contract dated September 28, 2020, which expired by its terms on October 1, 2025, due to the purchaser's failure to close. That property is also subject to the terms of a lease (to the same party) dated September 28, 2020, which by its terms expires on November 17, 2025. The Trustees do not currently plan to renew the lease and do expect to place the property on the market for sale.

Dear Friends in Christ,

I want to start with a huge thank you to the Presbytery of Sheppards and Lapsley for being one of our mission partners. Your encouragement and support continues to make a huge difference in this shared calling to care for at-risk and homeless children and families entrusted to our care. I am pleased to bring several exciting updates on the ministry of the Home.

First – we just received our full reaccreditation with an overall commendation for the next 4 years from the faith-based EAGLE Accreditation Commission with a score of 99 out of 100. As previous member of the EAGLE Accreditation Commission for 6 years, I can lay witness that this level of very high recognition is rare by the Commission. In addition, we received specific commendations for our faith connection,



financial management, community involvement, workplace culture and marketing. If you've talked to any of us or read any of our reports in the last year, you know this has been a major undertaking. We have thoroughly evaluated all our programs, our policies, our procedures, and everything else imaginable. We are excited to receive such high marks and excited for what this process means for our future and even a new initiative God led us to start because of our self-study. Rev. Leeann Scarbrough, Director of Spiritual Life and Pastor of First Talladega reflected and recently said, "Reaccreditation is not simply a seal of approval; it's a witness to a living faith. The Home's work shows what happens when people come together with a shared purpose to nurture, to heal, and to serve as Christ calls us to do."

We have also been working on our renovated playground with a new pavilion together to be named the Felicia Ayers Storey Playground. The work is almost completed! We made sure that we did it right. It has colorful and industrial-made playground equipment that is properly grounded with the rest of the area prepped for a proper play space for our children. The work on the pavilion is almost complete so that our moms can enjoy some shade while their kids play. We even have plans to finish a bathroom in the pavilion in the near future.

On top of construction activities around campus, our program staff has been busy with

celebrations! Have you seen a copy of our summer edition of *Beginnings*? It features one of the families from our Secure Dwellings program. Rebecca and her sons came to the Home in June 2024 after leaving an abusive boyfriend and living in a relative's garage. Our team went to work helping Rebecca find a good job and place the boys in Ascension Leadership Academy and Head Start. We are so proud of this entire family and what they accomplished in just one



year at PHFC. Our first celebration of the summer was for them! As Rebecca prepared to move into her new apartment in town, she said, "God made this possible."

You've probably heard us tell you the story of a mom who lived in her Chevy Blazer for weeks with her three young children! Tameka's husband died in a car wreck when she was pregnant with twin girls. They already had a young son named Tristan. Tameka tried her best

to support three children on her own... but when the kids got sick, she missed too much work and lost her job and then their apartment. She came to us after weeks in that Blazer. And Tameka recently graduated from our Secure Dwellings program! On Facebook, there is the cutest picture of Tristan wearing my suit coat at the graduation reception. I was hanging out with him and Tristan asked if he could wear it.





We had a third celebration for one of our Transition to Adult Living residents. This program helps young women ages 19-26. Some of these ladies have aged out of foster care or simply don't have a family that can support them financially or emotionally. One of our residents graduated from Talladega College this spring, so of course, we celebrated her and her accomplishments! The great thing is - she gets to remain with us.... She can find a job, earn some money, and continue to live with us until she is 26. This gives her a support system during this period of life when she needs it so much... when she's learning to budget those paychecks and truly transitioning into a full-fledged adult. Speaking of Talladega College, we are in talks with Dr. Willie Todd, Jr, the new president there to further our partnership with the College and serve even more young women.

We are always looking for the ways that God calls us to serve the community and those in need. During our accreditation process, we felt led to add a new initiative to our Secure Dwellings Program which currently provides safe and secure housing for children and their female caregivers that need a home. We are now working with DHR to help moms who have lost custody of their children due to unsuitable housing. We'll move them onto our campus and work to stabilize and strengthen these moms. Then, we will be in a strong position to advocate for them with DHR to get their children back to their mothers. Once

they regain custody of their children, they will move into one of our Secure Dwellings cottages with our other families or into suitable housing within the community. We already have two moms working through the process and we know that more are on their way to us soon!

We offer wrap-around care for all of our residents ... from counseling to financial literacy to life skills that so many never learned growing up. While we are physically located in Talladega, we accept families from across the state. Please keep our program in mind if you ever know of someone in need of our services.

We continue to partner with DHR to help families who have lost or are at-risk of losing their children to foster care. Our Family Bridges case workers do some amazing work to teach these families proper parenting skills. I was recently talking with Johnna McGowan, one of our case workers. She showed me the pictures of a home she visited. You wouldn't believe the sites and situations they encounter and the families that they help. If Presbyterians ever nominate someone for "sainthood," I think these ladies deserve a nod!

Our school – Ascension Leadership Academy has 55 students enrolled this year... that's the most in quite a while. With many of these additional students being kindergarten and first graders, we have renovated the basement into classrooms for our youngest grades so our



students can spread out. We also have at least six upper-class students earning college credits through dual enrollment that will help them toward completing their higher education goals. Our teachers do some incredible work to help these students thrive in the classroom, and we would love to host you for a visit anytime soon. I'm so very proud of each of our students and so very grateful for each of our teachers!

The Presbyterian Home for Children is also making a difference for students in rural Wilcox County through our partnership with local nonprofit M.I.N.D. (Mentoring in New Dimensions). Last year, we hosted a weekend backpack program to send food home with 40 children. This

year we've changed it up a bit. We realized an even greater need to help these children feel their best in class so that they can focus on learning. We have created a Caring Closet with essential supplies from clothing to underwear to deodorant. We even installed a washer and dryer so that teachers can now give the students fresh uniforms when they wear the same one to school three days in a row or when a student has an accident and soiled pants.



We also have food items in this Caring Closet to send home with the students experiencing food insecurity.

Our Caminos program staff has been working hard for the last year to place dozens of unaccompanied immigrant minors with their relatives to help protect them from abuse, exploitation or trafficking and to help them assimilate into the community with needed educational, medical and legal services. We are currently preparing to receive 20 children per case manager and fill all vacancies on our service delivery team!

Union Village, our permanent housing community for Deaf, Blind, DeafBlind and multi- disabled individuals housing is growing! We completed tiny cottages 11 and 12 thanks to a generous gift from the congregation of Second Presbyterian Church when it merged with Edgewood Presbyterian Church. We also got a grant of \$7,663 for assistive and safety upgrades at the Union Village cottages that will pay for technology that will



improve the quality of life and safety of residents. This includes new Echo Dot smart speakers that make getting around the cottages easier for those with disabilities. The Dots are voice activated through Alexa and hook into smart switches and wall outlets that allow residents to turn on devices and Wi-Fi lights by giving voice commands. The grant also covered the cost of non-slip floor mats to ensure residents are safe.

Continuing with our beautiful and historic campus - at the February 2025 Board Meeting, the Property Committee Report given by Committee Chair John Myers, detailed a motion to authorize \$1.1M in critical, priority 1 and 2 deferred maintenance needs for campus infrastructure and program expansions on our historic campus after an extensive review led by Wes Harry, Director of Physical Plant. The Board of Trustees voted to approve this motion at the same meeting and proceeded to direct Wes and I to build a comprehensive plan to secure these renovations for the best value beginning this past summer and going into 2026.

At the May 2025 Board Meeting, the Board was updated on that plan which is now underway on campus as a major facilities reset over the next two years. As expected during this process, this \$1.1M price tag has increased related to these identified first and second priorities with the discovery of additional work that really needs to be done while a given

building on campus is temporarily vacated – we never know what we might find behind the walls of older buildings.

Before the end of 2025, we will complete exterior and interior renovations for First Decatur Cottage including a new roof and renovated kitchen, exterior and interior renovations for Whitfield and Robinson Cottages including renovated bathrooms and flooring, exterior

and interior renovations for Uptain Cottage including a new roofing, windows and flooring, exterior and interior renovation of the Bell Administrative Building; an interior remodeling of the Trinity Presbyterian Training Center; a renovation of a maintenance storage building into a maintenance apartment to enable Wes Harry to reside on campus full-time in his crucial role as Director of Physical Plant; removal of a small wellhouse in disrepair; a restoration of all of the original wood windows at Ascension Leadership Academy; and a comprehensive interior renovation of Gabbie Cottage in Union Village including new and renovated bathrooms.

Straddling both 2025 and 2026, we anticipate a new roof/exterior renovations and renovations of multiple bathrooms for Johnson Hall where our Transition to Adult Living young ladies reside along with new roofing and exterior renovations for Weatherly Hall, Social Services, the Chapel and the offices for Family Bridges. For Union Village in 2026, we are planning to complete comprehensive exterior and interior renovations including a new roof and new flooring for Jordan Cottage, minor external renovations to Northington Cottage and a comprehensive plan for Warner Cottage and Mohns Cottage which could possibly include 2027. Clearly, our restoration needs in 2026 will go well beyond the initial \$1.1M.

Additionally in 2027, we need to plan for repaving several large areas toward the front of campus, acquiring several vehicles for use in maintenance, programs, and development; reroof the gym; and making significant sewer infrastructure improvements at Union Village to enable continued additions of more tiny cottages.

Since 1891, our historic campus in Talladega continues to be a shelter of hope and healing to at-risk children, young adults and families where they can dream again. Our staff together with our mission partners like the Presbytery of Sheppards and Lapsley are literally the hands and feet of Christ with the sacred opportunity to work with these very precious lives.

And in the midst of it all, the Home just received an unmodified, clean opinion on the annual audit report for fiscal ending June 30, 2025, from our independent auditors, Borland Benefield, P.C.

Sometimes God reminds us, in the most unexpected places, why we do what we do. Not long ago, while driving through Mississippi after leading worship at Westminster Presbyterian Church in Decatur and then visiting my good friend and new Board Trustee for the Home beginning in January, Rev. John Brock at First Presbyterian Church of Tupelo, I stopped at a Wendy's for lunch. As I stood at the counter, the young woman behind the register looked at my Presbyterian Home for Children shirt and said, "The Presbyterian Home for Children changed my life."

Her name is Elizabeth, and she shared that she lived at the Home from 2006 to 2011 and attended what was then Hope Academy, now Ascension Leadership Academy. She talked about her teachers, her memories, and how those years helped her become who she is today. She wanted me



to meet her boss and even introduced me to the district manager who happened to be in town that day. She was proud of her journey, and I was so proud of her!

That moment reminded me that while our work often feels so big, with its cottages, programs, and accreditation reports, it always comes down to **one life at a time**.

Background Checks are being done by the Stated Clerk according to our Child and Youth/Vulnerable Protection Policy. The policy calls for such background checks to be on an every three year cycle. The only exemption is for those who are no longer engaged in ministry or who have had a "BGC" within the last three (3) years. Please contact the Stated Clerk with any questions or concerns you have in regards to Background Checks.

Per Capita: The ministry of the Stated Clerk, of the Assistant to the Stated Clerk, and of the Recording Clerk, are supported by our Per Capita Assessment which is to be \$31.84 per member in 2026. This figure is based on the costs of office expenses, meeting expenses, and salaries (\$15.16); This Presbytery pays the per capita due to the Synod (\$3.98) and to the General Assembly (\$11.26).; and \$1.00 goes to Campus Ministry. We ask congregations to pay their fair share based on membership of the previous year. Many thanks to the congregations which have supported Per Capita! Much encouragement to those congregations which have yet to give.

Administrative Commission of the Presbytery of Sheppards and Lapsley Guidelines for Distribution of Funds Received from the Dissolution/Dismissal of Congregations

Approved as amended February 15, 2024 Presbytery Meeting

The property of the Presbyterian Church (USA), of its councils and entities, and of its congregations, is a tool for the accomplishment of the mission of Jesus Christ in the world. (G-40201)

All property held by or for a congregation, a presbytery, a synod, the General Assembly, or the Presbyterian Church (USA), whether legal title is lodged in a corporation, a trustee or trustees, or an unincorporated association, and whether the property is used in programs of a congregation or of a higher council is retained for the production of income, is held in trust nevertheless for the use and benefit of the Presbyterian Church (USA). (G-4.0203)

Seeking, as a presbytery, to be faithful to the mission of Jesus Christ in the world, the Presbytery of Sheppards and Lapsley adopts the following policy that shall ordinarily apply to the dissolution or dismissal of a congregation noting that this policy does not automatically apply to congregations which were exempted from the Trust clause(G-4.0203) following the reunion of the Presbyterian Church in the United States and the United Presbyterian Church in the United States of America to form the Presbyterian Church (USA). The presbytery office keeps a record of all the congregations that duly took the "Southern Option." (G-4.0208)

This policy is in effect for the net proceeds of the property. Net proceeds are any monies remaining from the sale of any real estate owned by a church which has been closed after (a) all financial obligations of the church have been paid; (b) Presbytery has been reimbursed for any funds disbursed on behalf of the congregation during or after the dissolution process. In the event that the property is leased with or without an option to purchase, proceeds will become available when the rental is received and/or the full purchase amount is received.

Distribution will be as follows if there is not an active Session:

• 10% - a first fruit offering distributed to Presbyterian causes and institutions that have been meaningful to the life of the congregation and/or local ecumenical and benevolent causes that have been meaningful to the life of the congregation.

• 10% to the operating fund. Intended to help support the total ongoing presbytery ministry funded by the annual Operating Budget.

70% to Church Development and redevelopment/revitalization funds. Intended to promote new church development opportunities, new worshipping communities, and the redevelopment of existing congregations and ministries that are purposefully pursing plans designed to encourage and enhance vitality and growth of congregations.

- 10% to Reparative Justice. Starting with our specific history of complicity in actions that have favored certain communities over others, establish a fund that would use the money for reparative action efforts:
 - 1. Reparative action within the Presbytery community
 - 2. Reparative action beyond the Presbytery community
 - 3. Matching grants for congregations doing reparative action

From the Advisory Committee on Social Witness Policy (2020) "Encourage presbyteries to account for histories of race-based injustice when making choices about the disposition of properties when they are being sold or reallocated, attending to the wisdom of reparative justice and questions about, e.g., the origins of those properties, the means by which they were maintained, their potential use, the presence of historically marginalized communities in the area, and the impact of those properties on those communities."

Approve: Presbytery will elect a Commission of five members consisting of two elders, two teaching elders (one from Executive Council, one from COM) and one at-large member which will be nominated by the Nominating Committee. Those elected must have a working knowledge of the Presbytery. The Commission will clarify the Guidelines. Approved

Report of the Commission for the Legacy Fund for Enduring Witness Presbytery of Sheppards and Lapsley — November 2025

FOR INFORMATION:

The "New Commission" has decided on a new name:

The Commission for the Legacy Fund for Enduring Witness (LFEW Commission).

Our work is to oversee and manage the distribution of funds received from the dissolution/dismissal of congregations. When there is not an active Session, the net proceeds are to be distributed (as instructed by PSL guidelines approved in February 2025) as follows:

- 10% First Fruit Offering to causes that were meaningful to the life of the congregation
- 10% to the PSL Operating Fund
- 70% to Church Development and redevelopment/revitalization
- 10% to Reparative Justice

The LFEW Commission been exploring how other presbyteries are handling similar funds, how they are approaching church development, possible mechanisms for identifying need and granting funds, and the history of new church development, nurture, and grant processes in Sheppards and Lapsley.

- 1. The Commission voted to use funds already allotted to LFEW to reimburse the Presbytery of Sheppards and Lapsley \$43, 424 for major expenses incurred in the process of closing Fairfield Highlands.
- 2. The Commission voted to use funds for Church Development to make up to \$5,000 available to the Commissioned Pastor Program of the Presbytery.
- 3. The Commission voted to send the First Fruit Offering from Five Mile Presbyterian to support the YMCA Roebuck Revitalization project.

FOR ACTION:

1. The LFEW Commission recommends the following motion:

That the Commission for the Legacy Fund for Enduring Witness be composed of five members (two or three ruling elders and two or three teaching elders), with one member coming from Executive Council and one member coming from COM.

Rationale: Stated Clerk Jay Wilkins alerted us that the previous language approved by presbytery — "a Commission of five members consisting of two elders, two teaching elders (one from Executive Council, one from COM) and one at-large member." — could be read in a way that the current composition of the Commission does not satisfy. We are simply seeking to clarify the language to avoid confusion and to express the intent of the Presbytery.

Administrative Commission Report to Presbytery Providence AC November 20, 2025

The Providence Presbyterian Church Administrative Commission is winding down its work. Here is a summary of actions that have taken place since the last meeting of presbytery:

- ➤ Sale of all Providence Property to ARC of Montgomery closed mid-October. Proceeds of the sale have been deposited with The Presbyterian Foundation and a process for distribution will begin January 2026.
- Session approved a list of twelve mission partners who will receive a portion of the net sale of the property. The three main recipients are The Presbyterian Home for Children, Meals on Wheels of Montgomery, and Medical Outreach Ministries. Nine other organizations will receive donations to enhance ministry, including The Presbyterian Association of Musicians (PAM). The New Covenant Fund of Presbytery will also be a recipient.
- ➤ The Clerk of Session has made one final appeal to all remaining roll members of Providence to transfer their memberships to other worshipping communities by December 31, 2025.
- Providence needs to remain a fiduciary entity until the end of the calendar year in order to facilitate legal and accurate tax reporting for the year and closure of all accounts payable. Session will have at least one more meeting before establishing an actual date for formal dissolution.
